Whereas the Government of Haryana vide Notification No. 02/10/2019-1IB-II dated 05.01.2021 created Directorate of Micro, Small and Medium Enterprises, Haryana and reallocated business amongst Directorate of Micro, Small and Medium Enterprises (MSMEs); Directorate of Industries & Commerce and Directorate of Supplies & Disposals.

Whereas in the ibid notification, work of Quality Marketing (actually Marking) Centres stands allocated to Directorate of MSMEs at Sr. No. 37. The Quality Marking Centre is one and whole term for Quality Marking Centres (QMCs)/ Industrial Development Centres (IDCs)/ Heat Treatment Centres (HTCs).

Whereas work of QMCs is exclusively looked after by Directorate of MSME since the date of notification i.e. 05.01.2021 and funds required for the salary and expenses of QMCs, HTC, IDCs have been provided under the Scheme and the Budget Head of QMCs/IDCs/HTCs i.e."P-01-25-2851-51-102-76-98-R-V Establishment & Administration for Small Scale Industries, QMC, HTC, IDC etc.- Establishment Expenses" from Financial Year 2021-22 onwards w.e.f. 01.04.2021 and control thereof is with Directorate of Micro, Small and Medium Enterprises.

The total 156 sanctioned posts at Quality Marking Centres/ Industrial Development Centres/ Heat Treatment Centres at field offices and Headquarter as on 10.05.2021 is annexed as Annexure 'A'. Accordingly, these 156 sanctioned posts including working strength and vacant posts are transferred to Micro, Small and Medium Enterprises, Haryana on the same pay scale or FPL/ACPL whatever applicable. The working strength is transferred on the same post on which they were working in Industries & Commerce and on the same place of posting where they are working. Salaries of all employees of QMCs/HTCs/IDCs will be drawn from MSME Directorate and concerned field offices of QMCs w.e.f. 01.04.2021 from the allocated funds in the scheme "P-01-25-2851-51-102-76-98-R-V Establishment & Administration for Small Scale Industries, QMC, HTC, IDC etc.-Establishment Expenses". The employees so transferred shall be governed by concerned service rules of Industries & Commerce Department until the MSME, Haryana framed its own Service Rules.
