

## NOTICE

All the retrenched and adjusted employees of Haryana **State Small Industries and Export Corporation (HSSIEC)** and **Haryana State Handloom and Handicrafts Corporation (HSH&HC)** who were adjusted after 01-01-2006 as per the decision of the State Govt. in other Govt. Departments/Corporations/ Board etc in pursuance of Notification no. GSR-13/Const./Art-309/2006 dated 21-06-2006 are hereby informed that the State Government being a Welfare Government has agreed with the proposal for grant of fixed honorarium in lieu of pension to the said retrenched and later on adjusted employees of these corporations under the Scheme' HSMITC Honorarium scheme for adjusted employees' vide memo no. 04/07/2022-IIB-II dated 14-11-2022 as under ;-

1	Group 'D' employees	6,000/-
2	Group 'C' employees in the pay scale of clerk	11,000/-
3	Group 'C' employees in the pay scale of Assistant	12,000/-

Further, the State Govt. vide memo no .04/07/2022-1IB-II dated 09-06-2023 has agreed with the proposal of department to grant honorarium to the retrenched and adjusted employees of HSSIEC and HSH&HC on the following terms and conditions that the **honorarium will be available to those who have a PPP ID and payment of honorarium would be linked to PPP.**

1. As the former HSMITC employees were adjusted after 01.01.2006 as per decision of the Govt. in the other Departments. The other employees of the department are getting pension as per



rules but these retrenched employees, later on adjusted, are not getting pension as they were covered under NPS/ any superannuation. So, being welfare of State, the State Govt. had considered the issue of these employees for grant of Honorarium. Therefore, the name of scheme be called as "HSMITC Honorarium Scheme for adjusted employees."

2. The payment of Honorarium shall be applicable with effect from 01.10.2020 (1<sup>st</sup> October 2020).

3. The retrenched and adjusted employees must be on the role of HSSIEC and HSH&HC as Group-'D' employees, Group-'C' employees in the pay scale of Clerk, Group-'C' employees in the pay scale of Assistant, Group-'B' employees and Group 'A' employees at the time of their retrenchment due to closure of the Corporation and adjustment in pursuance of Notification No. GSR-13/Const./Art/309/2006 dated the 21<sup>th</sup> June, 2006.


4. These retrenched and adjusted employees of HSSIEC and HSH&HC will be entitled only for fixed Honorarium, which will be granted on monthly basis and no. D.A. and any other allowance will be admissible to these retrenched and adjusted employees on fixed amount of Honorarium.

5. The amount will be drawn & disbursed at the level Head Quarter i.e. Directorate of MSME and will be disbursed to the respective retrenched and adjusted employees of HSSIEC and HSH&HC in their respective Bank Accounts every month. The Honorarium will be granted only to those retrenched and later on adjusted employees of HSSIEC and HSH&HC who are not getting any other such type of pension benefits from any State Government other Department/ Board/Corporation etc. as per their policy. In case, it is found that he/she is already getting any other kind of pension then this Honorarium will be stopped with immediate effect and the said employee will be liable to refund the such paid amount of Honorarium from the receiver with interest @ 9% per annum.



6. If, the eligible retrenched and adjusted employee is getting old age pension of the State then he/she shall surrender the same before getting the fixed Honorarium in lieu of pension in the said policy.
7. The Honorarium Scheme shall not be applicable to the spouse (Widow/Widower) or the legal heir of the deceased retrenched & adjusted later on employees of HSSIEC and HSH&HC.
8. The eligible retrenched and adjusted employee will have to submit an application along with an affidavit affirming therein the above terms and conditions for Grant of Honorarium to the office of Director General, Micro Small and Medium Enterprises, Haryana which will issue the by name of sanction of Honorarium after due verification of all records of retrenched and later on adjusted employees.
9. The annual/half yearly life certificate shall be taken in the same manner as is being taken in the regular pensioners of the State Government by the office of Directorate, MSME.

In view of aforesaid memos dated 14.11.2022 and 09.06.2023, the Department is to release the honorarium to the eligible retrenched and adjusted employees of both the Corporation. Therefore, All the eligible retrenched and later on adjusted in pursuance of State Government notification GSR-13/Const./Art-309/2006 dated 21-06-2006 are further directed to furnish the information on the prescribed Performa enclosed with this notice duly supported by relevant documents and affidavit duly attested from the notary .
