All the retrenched and Unadjusted employees of Haryana State Small Industries and Export Corporation (HSSIEC) and Haryana State Handloom and Handicrafts Corporation (HSH&HC) are hereby informed that the Government agrees with the proposal of department to grant honorarium in lieu of pension to the retrenched and unadjusted employees of Haryana State Small Industries and Export Corporation (HSSIEC) and Haryana State Handloom and Handicrafts Corporation (HSH&HC) in lieu of pension already paid to retrenched and adjusted employees of HSSIEC and HSH&HC vide memo no 14/01/2025-11B-II dated 18-11-2025 as per following term and conditions.

The pattern of honorarium is reproduced as under:-

Sr. No.	Classification of employee	Rates of Honorarium Per month
1.	Group 'D' employees	6,000/-
2.	Group 'C' employees in the pay scale of Clerk	11,000/-
3.	Group 'C' employees in the pay scale of Assistant	12,000/-
4.	Group 'B' employees	16,000/-
5.	Group 'A' employees	20,000/-

With the following terms and conditions:-

- i) As the former HSSIEC and HSH&HC employees were adjusted after 01-01-2006 as per decision of the government in other departments. The other employees of the departments are getting pension as per rules, but these retrenched employees, later on adjusted, are not getting pension as they were covered under NPS. So, being welfare of State, the State Govt. has considered the issue of these employees for grant of Honorarium. Therefore, the name of scheme be called as "HSMITC Honorarium Scheme for retrenched and unadjusted employees".
- ii) The payment of Honorarium shall be applicable w.e.f 01-10-2020 (1st October, 2020) on monthly basis. No DA and other allowances will be applicable in this scheme.
- iii) The retrenched employees of HSSIEC and HSH&HC who were not adjusted in other department and are presently not working shall be entitled for this scheme.
- iv) Neither spouse (Widow/Widower) nor their legal heir of the deceased employee shall be entitled for this Honorarium Scheme.
- v) The retrenched employee who was adjusted in pursuance of the notification on dated 21-06-2006 and resigned from the service on any ground during his service tenure shall not be entitled for honorarium.
- vi) The annual/ half yearly life certificate shall be taken in the same manner as being taken in the regular pensioners of the State Government.

- vii) The honorarium will be granted only to those who are not getting any other such type of pension benefits from any State Government or other Department/Board/Corporation etc. as per their policy.

In case it is found that he/she is already getting any other kind of pension, then this honorarium will be stopped with immediate effect and the said employee will be liable to refund the paid amount of honorarium from the receiver with interest @9% per annum. If, the eligible retrenched and unadjusted employee is getting old age pension of the state then he /she shall surrender the same before getting the fixed honorarium in lieu of pension in the said policy.

The compensation amount of Rs. One lakh be recovered from these unadjusted employees with interest @ GPF interest paid to employees which was paid to the retrenched and unadjusted employees at the time of closing of HSSIEC and HSH&HC.

'The honorarium recipients be linked to PPP i.e they should possess PPP ID and payment be made online only directly to the account linked to PPP'.

In view of aforesaid memo no. 14/01/2025-1IB-II dated 18-11-2025 the department is to release the honorarium to the eligible retrenched and unadjusted employees of both the corporation. Therefore all the interested and eligible retrenched employees who were not adjusted are informed that they may furnish the information on the prescribed performa enclosed with this NOTICE duly supported by relevant documents and affidavit duly attested from the Notary.
