



ORDER

In pursuance of the approval accorded by the State Government vide Memo No. 14/01/2025-1IB-II dated 18.11.2025, a notice was issued vide No. Exp. Corp./MSME/Unadjusted/419 dated 16.01.2026. Through the said notice, all the interested and eligible retrenched and un-adjusted employees of Haryana State Small Industries and Export Corporation (HSSIEC) and Haryana State Handloom and Handicrafts Corporation (HSH&HC), who were not adjusted were informed to furnish the information on the prescribed proforma, along with the relevant supporting documents and affidavit duly attested by the notary. Accordingly total 57 applications were received in the office.

Subsequently, a Committee was constituted vide Office Orders dated 02.04.2026, conveyed vide Endst. No. Exp. Corp./MSME/2081 dated 02.04.2026, for scrutiny and examination of the claims received in response to the aforesaid notice.

The Committee, in its meeting held on 16.04.2026, 15.05.2026, 03.07.2026 and 23.07.2026 scrutinized and examined the applications along with the supporting documents. After due examination, the Committee found 13 retrenched and un-adjusted employees, who were subsequently adjusted, eligible for grant of fixed honorarium under the scheme "HSMITC Honorarium Scheme for retrenched and Un-adjusted Employees."

The details of the retrenched and un-adjusted employees found eligible, as per the recommendations of the Committee, is as under:-

Further, the committee has proposed that prior to release the payment applicant must submit their life certificate physically/by post in the office of Directorate MSME. In future also they will submit their life certificate in the month of April and November every year.

These all the eligible 13 retrenched and Un-adjusted employees as per **Annexure-I to VI** are directed to present their life certificate physically in the office of Directorate, MSME so that fix honorarium w.e.f. 01.10.2020 OR eligibility date can be drawn as per decision of the State Govt.

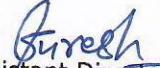
