CIRCULAR

Subject: Selection of State Haj Inspectors (SHIs) for Haj-2026 G (1447 H)

State Haj Inspectors (SHIs) play a vital role in assisting Haj pilgrims during their pilgrimage. Deputed from States and Union Territories, they support the Consulate General of India, Jeddah (CGI) in ensuring effective welfare services for pilgrims.

- 2. The Haj Committee of India (HCoI) hereby invites online applications from eligible male and female permanent government employees for short-term deputation as State Haj Inspectors (SHIs) for Haj–2026 G (1447 H) in the Kingdom of Saudi Arabia (KSA).
- 3. The deputation period will be approximately two months, between 13.04.2026 and 05.07.2026. It shall be treated as duty, and necessary entries shall be made in the service records by the parent departments. During this period, SHIs will continue to draw their salaries and allowances from their parent departments.
- 4. SHIs shall travel with the pilgrims assigned to them from their respective embarkation points to KSA and back. They will be provided travel arrangements from embarkation point and back, accommodation in Makkah and Madinah, essential transport services within KSA as provided to pilgrims, and a fixed allowance of SAR 3100 only. 50% of the expenditure on SHIs including fixed allowance shall be borne by the HCoI and the remaining by the respective State/UT Haj Committees.
- 5. Selection of SHIs will be carried out through a structured process involving Computer-based Test (CBT), Interview/Personality Test, and Medical Fitness Test. The eligibility criteria, selection process, tentative timeline, and roles and responsibilities are as follows:
- 6. Eligibility Criteria: Applicants must meet the following conditions to be considered for selection as SHI for Haj-2026:
 - i. Only Muslim candidates are eligible to apply.
 - ii. Must be a **permanent employee** of the Central/State Governments, Paramilitary Forces, Autonomous Bodies, or Public Sector Undertakings (PSUs) of the Central/State Governments. Group "A" / Class-I officers of the Central or State Governments (or equivalent) are not eligible.
 - iii. Must hold a Graduate degree from a recognized institution.
 - iv. Age must be below 50 years as on the date of opening of the online application.

- v. Must possess a valid Indian International Passport, with validity at least up to 31st December 2026.
- vi. Must have proficiency in English, Urdu, Hindi, and/or local language. Preference shall be given to candidates knowing Arabic language also.
- vii. Must be physically and mentally fit, computer literate, and conversant with the Haj Suvidha App.
- viii. Must have adequate knowledge of Haj rituals and logistics and the ability to effectively address and guide large gatherings.
- ix. Should not have served as SHI / Khadim-ul-Hujjaj more than three times in their career.
- x. Candidates against whom adverse comments have been received from CGI, Jeddah during their past deployment on Haj duty as KuH/SHI or deputationist in KSA will not be eligible.

7. Selection Process

- A tentative total of 805 candidates shall be selected in the ratio of 01 SHI for every 150 pilgrims. The State/UT-wise tentative allocation of SHIs to be selected is placed at Annexure-I.
- ii. 25% of the seats shall be reserved for SHIs / Haj deputationists who have demonstrated exemplary performance during the past five years.
- iii. 20% of the seats shall be reserved for candidates who have performed Haj in the recent past, preferably within the last five years.
- 5% of the seats shall be reserved for employees of State/UT Haj Committees and Waqf Boards.
- v. 50% of the seats shall be open to all eligible candidates.
- vi. Interested candidates should check their eligibility and apply online on the HCol website https://hajcommittee.gov.in and upload the requisite documents. No offline application will be accepted.
- vii. Candidates must upload a **No Objection Certificate** (**NOC**) from the employer (as per the format available at **Annexure-II**). In case NOC is not issued at the time of application, candidates must upload an Undertaking (format at **Annexure-III**) to submit it at the time of interview.
- viii. Selection will be made on merit, to be determined from the combined score of the CBT (150 marks, format and syllabus at **Annexure-IV**), and the Interview/Personality Test (50 marks, parameters at **Annexure-V**). However, candidates must secure a minimum of 50% marks separately in both CBT and Interview to qualify. Besides, all CBT-qualified candidates will be required to undergo and qualify the Medical Fitness Test (proforma at **Annexure-VI**).
- ix. The waitlisted candidates shall be selected in case any of the recommended candidates are unable to proceed as SHI.
- x. SHIs who are found neglecting their assigned duties shall be liable to be deported summarily. Accordingly, their replacement shall be selected from the waitlist.

9. Duties, Responsibilities & Code of Conduct for SHIs

- Attendance at the training programme organized by HCoI is compulsory; failure will result in cancellation of selection.
- Applicants must be fully vaccinated as per the Health Guidelines issued by the Kingdom of Saudi Arabia (KSA) for Haj-2026.
- SHIs shall travel with pilgrims from their respective State/UT in both outbound and inbound flights; separate travel is not permitted.
- iv. No family member is permitted to accompany an SHI on the pilgrimage.
- On arrival in KSA, SHIs must report to the SHI Cell in IHPO (Makkah/Madinah), follow CGI instructions, and report daily to the IHPO.
- vi. SHIs must have no connection with any Saudi Tawafa Establishment (Mu'allim).
- vii. SHIs must assist and guide pilgrims throughout their journey and stay in KSA, update their knowledge on Haj logistics, and remain accessible at embarkation points.
- viii. SHIs must maintain continuous contact with assigned pilgrims, recording details in their Register and Haj Suvidha App.
- ix. SHIs must perform their duties with full commitment. Those found underperforming, abandoning pilgrims, switching off mobile, or against whom adverse feedback is received shall be immediately recalled, repatriated, blacklisted from future Haj duties, and reported to their parent departments for disciplinary action.
- x. In case of issues with Mu'allims, SHIs must intervene tactfully. If unresolved, a written complaint with full pilgrim details should be escalated to CGI, either physically or via Haj Suvidha App.
- xi. In dealing with Moallims, SHI has to be cautious about using harsh words or speaking unparliamentary language or mounting pressure as it might result in difficulties to the pilgrims as a whole.
- xii. Before returning to India, each SHI must submit a report along with the pilgrim Register to CGI, detailing difficulties faced and services rendered.

10. Role & Responsibilities of State/UT Haj Committees

- Scrutinize candidate applications, assess eligibility as per prescribed criteria, and prepare a verification report for each applicant in the format at Annexure-VII. Upload the reports on the HCoI portal and submit consolidated lists of eligible and ineligible candidates, along with individual reports, within the timeline specified by HCoI.
- ii. Extend necessary support, as and when required, to HCoI for the conduct of selection process and CBT.
- iii. Conduct interviews of candidates qualified through CBT, in consultation with HCoI and as per the provisions of **Annexure-V**, and submit the scores to HCoI within the stipulated timeline. In case any SHC fails to complete this process within the prescribed timeline, HCoI may finalize the selection of SHIs on the basis of CBT scores alone.
- iv. SHCs shall provide each SHI with a regional language translation of duties/responsibilities for study and guidance.
- v. Ensure constant communication with SHIs of respective State and monitor their performance.

CBT FORMAT AND SYLLABUS FOR SELECTION OF SHIS

A. CBT Format

- A.1. The computer-based test shall carry 150 marks with 50 multiple choice questions of two types: (a) 25 fact-based; and (b) 25 situation/case scenario-based. The test duration shall be 120 minutes.
- A.2. Fact-based questions shall carry 50 marks, each having one right and three wrong choices, right choice carrying 2 marks and wrong choices having zero marks. No question shall have negative mark.
- A.3. Situation/case scenario-based questions shall carry 100 marks. Each question shall have four choices, each carrying 1-4 marks based on appropriateness to the situation. The best choice shall carry 4 marks and the least preferred choice shall carry 1 mark. No question in this category shall have zero or negative mark.

B. Syllabus for CBT

The test syllabus for State Haj Inspectors will mainly cover the following aspects:

B.1. Introduction to Haj & Islamic Practices

- · Significance of Haj, rites, and rituals.
- · Code of conduct for pilgrims

B.2. Responsibilities of Haj Inspectors

- Safety & Security: Ensuring pilgrim safety, crowd control, emergency procedures.
- Logistics: Transport, accommodation and essential services monitoring.

B.3. Health & Safety

- First Aid & Medical Emergencies: Basic first aid, common health issues, disease control.
- Welfare: Mental health support for pilgrims.

B.4. Technology & Communication

- Technology Use: GPS, digital tracking, online registration, and data management.
- Digital Literacy: Proficiency in using smartphones, Haj Suvidha App; Knowledge of MS Office tools: Word, Excel, and PowerPoint.
- Communication Skills: Effective interaction with pilgrims, emergency communication protocols.

B.5. Cultural Sensitivity & Pilgrim Interaction

- Interpersonal Skills: Empathy, conflict resolution, managing expectations.
- Cultural Awareness: Understanding diverse pilgrim needs.

B.6. Administrative Skills

- Documentation: Accurate reporting of incidents, health, and logistics.
- Compliance: Ensuring adherence to regulations and audits.

B.7. Professional Ethics & Integrity

• Ethics: Transparency, preventing corruption, and ensuring accountability.

B.8. Case Studies & Scenarios

- Crisis Scenarios: Managing illness outbreaks, crowd surges, emergencies (e.g., medical, logistical, or procedural)
