Director, ISLRTC, welcomed the Chairperson and all others Members/participants and thereafter with the permission of the Chair, agenda items were discussed and considered.

#### **Item No. 28.1 Confirmation of the minutes of 27<sup>th</sup> meeting of EC held on 06<sup>th</sup> March, 2024**

The Council accorded ex-post facto approval for conducting workshop on basic ISL skills for special educators of the Deaf conducted at AWES with the expenditure of Rs. 2,24,113/- and at AIISH, Mysuru with financial implication of Rs. 1,98,000/-

#### **Item no. 28.6** Enhancement of NPS Government Contribution from 10% to 14%

The Council approved the proposal for adoption of Gazette Notification No.1/3/2016-PR dated 31.01.2019 issued by Department of Financial Service, Ministry of Finance, in accordance to the OM dated 26th Aug, 2021, issued by Department of Expenditure, Ministry of Finance for enhancement of employer's contribution towards NPS subscription from 10% to 14% of Pay & DA w.e.f. 01<sup>st</sup> April, 2019.

#### **Item No. 28.7 Honorarium for non-officials in the National Committee on ISL**

The Council accorded ex-post facto approval for honorarium paid @ 2000/- per day/per head i.e Rs.70,000/- and an amount of Rs.49652/- paid towards TA/DA to non-officials members participated in the National Committee meeting on ISL held in Jan 2024.

#### Item no. 28.8 EOI for Development of Sign Vocabulary in ISL

The Council accorded ex-post facto approval for the expenditure incurred of Rs.20,288/- incurred by the Centre towards advertisement of EoI in News Paper in March 2024, through Central Bureau of Communication, New Delhi.

#### **Item no. 28.9 Commencement of DISLI Course at NI's and CRC's**

The Council asked Member Secretary, RCI to ensure that the approval to the NI's/ CRC's for conducting DISLI and DTISL course is issued expeditiously, to extend the date of admission and review the norms for engagement of Instructor(Deaf) for the purpose of teaching in DISLI and DTISL course.

#### **Item no. 28.10** Assignment of Roles for subscription towards New Pension Scheme

The Council accorded ex-post facto approval to the proposal of Centre for management of subscription towards New Pension Scheme as per the guidelines of PFRDA.

#### Item no. 28.11 Refund of caution money

The Council accorded ex-post facto approval, as proposed by the Centre, for refund of caution money with an financial implication of Rs. 1,00,000/- from the Internal Accrual to DISLI and DTISL of Academic Session 2021-23 and 2020-22.

#### Item no. 28.12 Honorarium for external committee members

The Council accorded ex-post facto approval for sitting fees of Rs. 2,500/- + local TA, paid to each external committee members, participated in the meeting held at Centre, for final selection of candidates based on merit and reservation policy for admission in DISLI and DTISL Course for 2024-25 academic session.

#### **Item no. 28.13 Implementation of Leave Travel Concession (LTC)**

The Council in principle granted approval for availing Leave Travel Concession (LTC) facility by the employees from the Financial Year 2024-25 with a direction that the Centre to check with other NI's to have common practice. The expenditure to be met from funds received in Grant-in-Aid from Department, under Salary head.

#### Item no. 28.14 Hiring of vehicle

The Council accorded ex-post facto approval for extending the contract of M/s Seven Tigers, New Delhi, engaged through GeM, to provide a vehicle, for further period of 01 year from 04.07.2024 to 03.07.2025 on same rates i.e Rs.38,900/- P.M and with the total financial implication of Rs.4,66,800/- per annum and on same terms and conditions.

#### **Item no. 28.15** Engagement of Internal Auditor

The Council accorded ex-post facto approval for extending the contract period of M/s Mack & Associates, as Internal Auditor for Financial Year 2024-25 with a 5% escalation is Rs. 32,210/- (Rs. 27,297/- + GST as applicable) as per the contract and on the same rates and same terms & conditions.

#### <u>Providing Interpreter services to Ministries/Department, located Delhi and to all</u> <u>National Institutes under DEPwD.</u>

The Council approved the proposal submitted to Department for providing 01 ISL Interpreter in 19 CDEIC and 01 in NIMHR with an financial implication of Rs. 1,20,40,000/- for the period of 01 year. However, the Centre was asked to follow the remuneration decided by National Fund for the Interpreters and to provide Interpreter only in such NI's where the DISLI Course is not conducted and the NI's have not engaged Interpreter in some other scheme.

#### Additional Item No. 1 Collaborations/MoUs with possible Organizations

The Council noted and approved all the Collaborations/MoUs signed/proposed by the Centre.

### <u>Additional Item No. 2</u> <u>Free Online English Course for Deaf Youth</u>

The Council noted the action taken by the Centre, for facilitating the hearing impaired to learn English. Further to have a quality and to maintain standard of the Course the Council directed that the Centre to involve EC members, school teachers and other experts in the field to review and validate the English classes conducted through online/offline mode. Accordingly, the Council approved the proposal to engage 03 more English teachers (Deaf) for a period of 03 months with a monthly remuneration of Rs. 40,000/- with total financial implication of Rs. 3,60,000/- .

#### <u>Additional Item No. 3</u> <u>Increase in intake capacity from 40 to 120 in DTISL course</u>

The Council noted and appreciated the action taken by the Centre for increasing the intake capacity and to provide opportunity to the hearing impaired students.

#### Additional Item No. 4 Engagement of additional Instructors and Master Trainers on contract basis

The Council in principal approved the proposal for engagement of additional Instructor, however the actual engagement may be decided based on the actual requirement, after utilising the all the existing regular faculty.

2. In this regard, the council also directed that the Centre may review the requirement and resubmit the proposal within a week, with proper justification supported with time table, showing the optimal use of available resource, work allocation, academic calendar, course curriculum etc.

3. Further, to manage the teaching assignment at the Centre, the Council accorded approval to extend the tenure of ISL Instructors and Project Assistant already engaged on contract till 30.09.2024 on same remuneration and same terms and conditions or till the new engagement is done, whichever is earlier.

#### <u>Additional Item No. 8</u> <u>Engagement of ISL Interpreters on contract basis</u>

The Council considered the proposal and directed that the Centre to take necessary action as per the decision taken on the proposal by Chairman National Fund and it was also directed that the Centre may ensure that the Interpreters may be engaged only for those NI's and CRCs who are not conducting DISLI course.
