## Recruitment of Assistant Professor and Librarian

The Council noted the recruitment process initiated by the Centre for the post of Assistant Professor (Sign Linguistics)-01, Assistant Professor (Interpreting)-01 and Librarian -01 and recommended following proposal of the Centre for further consideration of GC

The Director, ISLRTC and some of the Council members submitted that the ISL Interpreters are providing Interpreting services to various Court, wherein they are considered as witness and later, summon/arrest warrant are issued to provide subsequent Interpreting services for the case and sometimes, charges are also not been paid. It becomes very embarrassing, threat to life and unethical for the ISL Interpreter. The Council taken a serious view of the case and advised the Centre to submit a Draft letter to be send from DEPwD to Secretary, Ministry of Law and Supreme Court with a request that, to facilitate the hearing impaired with ISL Interpreter, to have unbiased Interpreting the Court may engage ISL interpreter on regular/contract basis, Interpreting provided by Interpreter to be recorded and the ISL Interpreter shall not be considered as witness of the case.
