

उपरोक्त विषय के सन्दर्भ में आपको लिखा जाता है कि सरकार के नियमानुसार अधिकारियों / कर्मचारियों की 55 वर्ष की आयु से आगे की सेवा में बने रहने के लिए 6 माह पूर्व निदेशालय में प्रस्तुत किये जाने चाहिए परन्तु इस मामले में प्रायः यह देखा गया है कि आपके कार्यालय द्वारा समय पर पूर्ण विवरण सहित नहीं भेजे जा रहे हैं जिस कारण अधिकारियों / कर्मचारियों की सेवा में वृद्धि के केसों में अनावश्यक देरी होती है। इस सम्बन्ध में आपसे अनुरोध है कि अधिकारियों / कर्मचारियों की 55 वर्ष से अधिक आयु से सेवा में रखने के मामले कम से कम 6 माह पूर्व पूर्ण विवरण सहित जैसे की अधिकारी / कर्मचारी का नाम, पद का नाम, जन्म तिथि, सरकारी सेवा ज्वाइन करने की तिथि, पिछले दस वर्षों की सेवा के दौरान का रिकार्ड के अलावा अधिकारी / कर्मचारी की ईमानदारी संदेहजनक तो नहीं है तथा ऐसी कोई अनुशासनिक कार्यवाही / न्यायालय में मामला लम्बित तो नहीं है तथा नियम 7 एवं 8 के तहत कोई आरोप पत्र जारी तो नहीं किया गया है जो विभाग के विचाराधीन हो के साथ इस निदेशालय को भेजे जाएं।

Subject:- Appointment to the post of Peon in New & Renewable Energy Department, Haryana.

On the recommendations of Haryana Staff Selection commission, you are offered a temporary appointment of Peon in New & Renewable Energy Department in level DL of the Pay Matrix level as specified in Haryana Civil Service (Revised Pay) rules, 2016. You will also draw the usual allowances as may be sanctioned by the Haryana Government from time to time and such allowances as may be admissible from time to time. This offer / appointment is further subject to the following conditions:-

- i) It should be clearly understood that your appointment to the post of Peon is purely on temporary basis. This post is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer on permanent vacancy can be made to you at present and in this respect you will have to take your chance like others who have been similarly recruited. Subsequently your services will be terminated without notice whenever there is no vacancy against which you can be retained.
- ii) In case, at any stage, while you remain in temporary capacity & desire to resign your post in the New & Renewable Energy Department, you will be required to give one month's notice or forfeit in lieu thereof, salary including allowances for one month's or for the period by which the notice falls short of one month. Such a notice can also be given to you by the Department in case it is proposed to terminate your services for reasons other than mentioned in para(i) above. Department will also be liable to pay salary including allowances for one month or for the period by which the notice falls short of one month. In case of misconduct, you will be given a reasonable opportunity to show cause as to why your services should not be terminated, in that case the condition of one month's notice shall not apply. - iii) You will be governed by New PENSION SCHEME, 2006.
- iv) In case you are married, you will have to give a declaration that you are not having more than one living spouse & you are not married to person having a living spouse.
- v) You will be on probation for a period of two years from the date of joining as per Haryana Group D Employees (Recruitment and Conditions of Service) Act, 2018. If your work and conduct during this period or at the end found unsatisfactory, your services will be dispensed with without any notice.
- vi) You will not undertake higher studies of any kind without obtaining prior permission of the competent authority. Consequently, no leave except examination date of any kind will be granted to you for the purpose of higher studies.
- vii) No T.A. will be granted for joining this appointment.
- viii) This offer of appointment is further subject to your submission of medical fitness certificate within 15 days from the date of appointment, failing which this appointment will stand cancelled.
- ix) As your character and antecedents have not been got verified in terms of Government Instructions issued vide Memo No.52/03/2005-6S(1) dated 18th November, 2005, therefore, it is made clear to you that in case subsequently any adverse facts come to the notice of the State Government regarding your character and antecedents, your services will liable to be terminated without giving any notice.
- x) You must submit:-
 - i) A declaration in writing that you were not in any previous occasion dismissed from service under any department of Government or convicted by a Court of Law or no case is pending against you in any Court of Law.
 - ii) In case you are married, you will have to file a declaration about non acceptance / giving of dowry. If you are unmarried, you shall have to furnish a declaration immediately after marriage regarding non acceptance / giving of dowry by you to the office as per declarations in annexure A and B in terms of government instructions issued vide No.18/1/2004-2GSI dated 21/02/2006.
- xi) While reporting for duty you will be required to produce your original educational certificate, date of birth certificate, PHC Certificate, Caste Certificate and Haryana State Resident Certificate, if applicable. On verification / checking of your qualification certificates at the time of joining, thereafter, if any discrepancy is found later on, in that case, your services from the post of Peon shall be terminated.


