The tour diary/detailed reports submitted by the Supervisory Officers will be reviewed by the W/DG, NRE and W/ACS, NRE.

It has also been decided by the Competent Authority the staff vehicle may be provided to the Supervisory Officers preferably from Head Office for visiting their allotted district/areas subject to availability of vehicles. In case the staff vehicle is not available at Head Office then the concerned Supervisory Officer may hire taxi after obtaining the prior approval of Competent Authority before start of journey.
