


ORDER

The services of Shri P.C. Sharma, Project Officer were placed as Consultant on deputation with ISA, Gurugram (International Solar Alliance). As per terms & conditions of deputation issued vide order Endst. No. DNRE/Admn-2017/3446-49 dated 12/10/2017, Shri P.C. Sharma, Project Officer relieved by ISA Gurugram on 10/07/2020 (A.N) vide order Endst No. A-01/15/2017-ISA dated 10/07/2020. Accordingly on repatriation from ISA, Shri P.C. Sharma, Project Officer joined in this Directorate (DNRE) on 13/07/2020 (being holiday on 11/07/2020-12/07/2020).

Further, Shri P.C. Sharma, Project Officer was to be retired from Govt. service on account of superannuation the age of 58 years. In view of that the salary of Shri P.C. Sharma, Project Officer was drawn for the period from 11/07/2020 to 10/08/2020 and 11/08/2020 to 30/09/2020 against the vacant post of Additional Director/Project Director respectively.

As per service book of Shri P.C. Sharma, Project Officer, his basic pay as on 01/07/2020 was Rs.99,500/-. Due to non-updation the data on HRMS portal by International Solar Alliance, Gurugram, the salary was generated @ Rs. 91,100/- + allowances. Due to that, the officer received less salary for the period from 11/07/2020 to 30/09/2020 as well as leave encashment. The above shortcoming came in notice after the retirement of Shri P.C. Sharma, Project Officer. By now, all the shortcomings have been got updated on HRMS portal with the help of NIC. Therefore, the difference amount may be released/ paid to Shri P.C. Sharma, Project Officer retired on 30/09/2020.
