In reference to the registered notice was issued vide no. 5271 dated 06.5.2021 and final registered notice issued vide no. 5555 dated 20.05.2021 also served through e-mail ( paawanenergy@gmail.com) on 07.06.2021, this office has not received any response or communication from you.

It is further informed that in reference to Grievances no. CMOFF/N/2019/110658 received on CM Window from Sh. Omprakash Yadav on 11.09.2019, ADC Mahendergarh was requested to sort out the issue between the supplier & user and upload the report on the CM Window Portal, the report was received from ADC, Mahendergarh.

As per the report of the committee, following is the details of the plant:

- 1. The RPS group of Institution, Balana- Mahendergarh had applied the application on Hareda portal online for the sanction of the subsidy for 20 Kwp solar power plant to be installed at RPS group of Institution, Balana- Mahendergarh.
- 2. ADC-CPO, NRE had sanctioned the application vide sanction no. 1734/17-04-2017 dated 17.04.2017 for 20 Kwp solar power plant (without battery bank and with net meter) to be installed at RPS group of Institution, Balana- Mahendergarh (copy attached).
- 3. The RPS group of Institution, Balana had given the work allocation for installation of 20 Kwp solar power plant to M/s Paawan Energy India Pvt. Ltd. (MNRE Channel Partner) at their own level.
- 4. As per the commissioning report dated 18.10.2017 submitted by RPS Group of Institution, M/s Paawan Energy India Pvt. Ltd. (MNRE Channel Partner) had installed the Grid Connected 20 Kwp solar power plant (without battery bank and with net meter) on dated 11.09.2017.
- 5. The supplier had given the Warranty/Guarantee and Declaration certificate for the 20 Kwp solar power plant (Copy attached). The supplier had also certified that SPV Solar Power Plant installed is in compliance with the latest minimum technical specifications of MNRE/Hareda.

As per General terms and conditions issued by Haryana Renewable Energy Development Agency (HAREDA) dated 01.06.2017, the applicant may install the system from any of the MNRE empanelled Channel Partner or by MNRE empanelled New Entrepreneurs by strictly

meeting out the minimum technical specifications prescribed by MNRE/DNRE from time to time. The MNRE approved components shall be used in the plant. Minimum Technical Specifications. So the supplier shall affirm as per standards for quality that anything to be furnished shall be new, free from all defects and faults in material, workmanship and manufacture, shall be of highest grade and consistent with established and generally accepted standards for material of the type ordered, shall be in full conformity with the specifications, drawing or samples, if any and shall if operable, operate properly.

In addition to above, vide Detailed Technical Specifications issued by department on dated 01.06.2017, it is also specified that the PV module should be mounted on structures of adequate strength and appropriate design, which can withstand load of modules and high wind velocities up to 150 Km per hour.

On considering the report of the committee, it is observed that the system has not been installed as per specifications of MNRE/HAREDA. Also inspite of various reminders, requests and notices, the said system has not been rectified by you thereby you are responsible for not adhering the technical specifications/ guidelines at the time of installation of the system.

Therefore, on considering all the facts and circumstances, your firm, i.e. M/s Paawan Energy India Pvt. Ltd., has been black listed for a period of one year for participating in any government works.
