### ORDER

On reinstatement Shri Pardeep Kumar, Assistant Project Officer is hereby posted in the office of Additional Deputy Commissioner-cum-Chief Project Officer, NRE Hisar against vacant post and also assigned the additional duties of Assistant Project Officer O/o Additional Deputy Commissioner-cum-Chief Project Officer, NRE, Sirsa twice in a week in addition to his present posting at Hisar till further order.

His reinstatement is without prejudice to the disciplinary action that may be taken against him and also without prejudice to the decision that may be taken regarding the period for which he remained under suspension. However, in case, Shri Pardeep Kumar, Assistant Project Officer is convicted by the court, the same will be implemented accordingly.


