**ORDER**

Shri Pradeep Nautiyal who is going to retire from the post of Chief Scientific Engineer, HAREDA after attaining the age of superannuation on dated 30<sup>th</sup> November, 2021, is hereby appointed as Technical Expert for a period of one year after his retirement in HAREDA, subject to Subsequent ratification by Board of Governors (BOG), the Governing Body of HAREDA and the following are terms & conditions of his appointment:-

1. Sh. Pradeep Kumar Nautiyal will be paid remuneration 50% of last basic Pay drawn before retirement + DA as applicable time to time per month for a period of one year with effect from 1.12.2021 as Technical Expert.
2. No other allowance shall be payable to him.
3. Tax on salary shall be deducted as per prevalent/relevant rules.
4. He will be designated as Technical Expert and will be entitled to TA, DA in accordance Rule-10 under Chapter-III, General of the Haryana Civil Services (TA) Rules, 2016 as applicable time to time to Grade-III officers i.e. Grade pay Rs. 4600 to 8800.
5. He will supervise and monitor the work assigned to him by the Director General, HAREDA from time to time.
6. Leave etc. will be applicable to contractual employees in accordance of the Haryana Civil Services (leave) Rules, 2016.
7. The services can be terminated at one month's notice by either party.
8. In all matters the decision of the Director General, HAREDA will be final and binding.


