Guidelines/Procedure for registration of Solar Power Projects with Haryana Renewable Development Agency (HAREDA).

- These guidelines shall apply to the applications made for the registration of the solar power projects with HAREDA. These are issued in accordance with the detail procedure for grant of connectivity and intra state open access issued by Haryana Electricity Regulatory Commission vide No. 162-166/HERC/Tariff dated 15.04.2021. These guidelines shall come into effect from the date of issue.
- 2. For a solar power generating station or a captive solar power generating station (called solar power project), New & Renewable Energy Department, Haryana/ HAREDA is the nodal agency to register the projects as per applicable HERC Regulation No. HERC/53/2021 clause 64 dated 30.04.2021, while STU (HVPNL) shall be the Nodal agency for grant of connectivity to such projects.
- 3. The applicant developer has to apply to HAREDA for registration of solar power project in the prescribed format (Annexure-I) along with copy to DISCOMs for ascertaining captive status by the respective DISCOM. If the solar power project is captive, then the captive nature of the project shall be provided at the time of application for registration of the project. If the applicant Solar Project Developer (SPD) is a joint venture of more than one companies, then the shareholding pattern of each company shall be provided with the application. The details of shareholding of the companies/captive users, and projects, the details regarding drawal point(s) shall be provided. For such apply online on portal of HAREDA, however, till the software is developed, may be applied in physical form.
- After registration of the solar power projects with HAREDA, a registration number will be generated for each project.
- 5. The detailed project report (DPR) shall be submitted to HAREDA along with the application for registration of project.
- No application fee shall be charged by HAREDA for registration of the solar power projects.
- 7. Agreement to lease or agreement to sell or registered agreement to lease or registered agreement to sell or lease deed or sale deed for minimum 50% of the land required is to be submitted by the applicant solar project developer with the application. However, if the applicant has submitted agreement to lease or agreement to sale, the same should be notarized and should have the details of the amount paid to the land owner(s), which should be minimum Rs. 1000/- per acre (as token money) supported with bank statement of SPD/ written proof of payments to the land owner(s). Already registered solar projects (with HAREDA) are not required to submit these documents.
- 8. Land requirement shall be minimum 3.5 acre per MW. However, any SPD who intends to develop the solar project in less than 3.5 acre/MW, then the SPD shall have to provide technological details proving the lesser requirement of land per MW which may be evaluated by HAREDA at the time of registration of the project.
- Registration of the solar power project by HAREDA does not mean approval of the project and does not guarantee the grant of connectivity from HVPNL. The grant of connectivity shall be governed by the procedure and guidelines of HVPNL/Power Utilities.

- 10. SPD shall allow to inspect the project by officers of the HAREDA/NRE Department or its
- 11. The total capacity of Solar PV Projects to be allocated to a Company/Firm including its Parent, Affiliate or Ultimate Parent-or any Group Company shall be limited to 100 MW. The Company, including its Parent, Affiliate or Ultimate Parent or any Group Company may submit application/proposal for a maximum of five projects at different locations subject to a maximum aggregate capacity of 100 MW.
- 12. All project developers shall be required to submit monthly reports with regard to parameter like energy generated, self-consumption, energy sold, revenue earned, power factor and plant load factor achieved, reasons for non-achievement of full generation and any other information so called for by Renewable Energy Department/HAREDA/Power Utilities so as to maintain and update data bank on solar power generation in the state and also for the purpose of monitoring of generation under RPO regulations.
- 13. The Project Developer shall obtain all required statutory/non-statutory clearances for the
- 14. Wherever these guidelines are found to be in conflict with safety, health or environmental statutes/codes/provisions of any act of law, the latter will take precedence over these
- 15. Project Developer shall submit the post commissioning details like date of commissioning, connectivity status, benefit availed etc. to HAREDA.
- 16. The Administrative Secretary to Govt. of Haryana, New & Renewable Energy Department shall have the powers to issue clarification or to interpret or amend or relax any provision of these guidelines within the ambit of Solar Policy and relevant
