

Subject:- Implementation of section 37 of the Rights of Persons with Disabilities (RPwD) Act, 2016-Special Schemes & Development Programmes.

Will the Scheme Incharges refer to the subject cited above?

Section 37 of "The Rights of Persons with Disabilities (RPwD) Act, 2016, which mandates are as under:-


The appropriate Government and the local authorities shall, by notification, make schemes in favour of persons with benchmark disabilities, to provide,-

- a) Five percent reservation in allotment of agricultural land and housing in all relevant schemes and development programmes, with appropriate priority to women with benchmark disabilities;
- b) Five per cent reservation in all poverty alleviation and various developmental schemes with priority to women with benchmark disabilities;
- c) Five per cent reservation in allotment of land on concessional rate, where such land is to be used for the purpose of promoting housing, shelter, setting up of occupation, business, enterprise, recreation centres and production centres.

The Department of Social Justice & Empowerment, Haryana being the nodal department for the implementation of the RPwD Act, 2016 advises all the departments to formulate schemes in favour of Persons with Benchmark Disabilities on the above mentioned subjects, including the special emphasis on women also requested to ensure that schemes shall be made and executed in accordance with above mentioned provision of law.

In the ^{above} ~~same~~ context, all the scheme incharges of DNRE/HAREDA is requested to formulate schemes in favour of Persons with Benchmark Disabilities and also ensure the "Implementation of section 37 of the Rights of Persons with Disabilities (RPwD) Act, 2016-Special Schemes & Development Programmes".
