ORDER

1. The Appellant filed first appeal on 29.09.2023 under Section 19 (1) of the Right to Information Act, 2005 and received by the office of First Appellate Authority (FAA) on 13.10.2023 from ADC, Sirsa in connection with his application dated 25.08.2023 to provide information from Project Officer-cum-Assistant State Public Information Officer, Office of Additional Deputy Commissioner-cum - Chief Project Officer, Sirsa which received to them by speed post on 04.09.2023.
2. The Appellant has informed in the instant appeals that no information has been provided.
3. First Appellate Authority (FAA) directed the ASPIO, Sirsa to provide the point wise desired information to the Appellant under intimation to this office by 23.10.2023 and personally appear on 26.10.2023 at 11:30 AM with the information provided. Further, the Appellant was also intimated vide letter dated 19.10.2023 to appear before FAA on said schedule, if information is not provided or not satisfied with information provided.
4. The following were present on the date of hearing:
 - i. Sanjeev Kumar, Project Officer-cum- Assistant Project Officer, Office of Additional Deputy Commissioner-cum-Chief Project Officer, Sirsa- Respondent.
 - ii. Appellant was not present on hearing.

5. I have gone through the contents of his appeal dated 29.09.2023 and also the application dated 25.08.2023 and heard the respondent, ASPIO, Sirsa.
6. ASPIO, Sirsa has informed that the desired information was provided to appellant initially on dated 05.10.2023 through Speed Post No.IVR:8272629808170 in response to his application dated 25.08.2023 Further, the desired information was again provided on dated 25.10.2023 through Speed Post No.IVR:8272645905590 in response to the direction issued by FAA.
7. This office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
8. Observations : It is observed that vide his RTI application dated 29.09.2023 the Appellant has sought information on the following points and ASPIO, Sirsa has also provided reply as under:-
