ORDER

1. The Appellant filed his first appeal on 29.05.2024 under Section 19 (1) of the Right to Information Act-2005 in connection with his application dated 01.04.2024 for providing information from the SPIO-cum-Assistant District Attorney, New & Renewable Energy Department, Haryana and received by the office of First Appellate Authority (FAA) on 03.06.2024 Panchkula.
2. The Appellant has been informed that incomplete information has been provided to him.
3. First Appellate Authority (FAA) directed the SPIO-cum-Assistant District Attorney, NRE, Panchkula to provide the point wise desired information to the Appellant under intimation to this office by 14.06.2024 and to appear before FAA personally on 18.06.2024 at 12:30 PM with the details of the information provided to appellant.
4. The Appellant was called on 18/06/2024 but he did not appear. However, SPIO appeared before FAA. SPIO, NRE has informed that the information was again sent to the appellant vide letter No. 1568 dated 12.06.2024. Further, another date for a personal hearing was afforded to the appellant on 02.07.2024.
5. Observations: It is observed that, vide his RTI application dated 29.05.2024 the Appellant has sought information on the following points and SPIO-cum-ADA, HQ, Panchkula has also provided reply as under:-

The appellant again not appeared on 02.07.2024, but he informed vide mail dated 02/07/2024 that :


- i. It shall not be feasible for me attend the hearing today the 2nd July, 2024 due to the health problem.
