ORDER

1. The Appellant filed his first appeal on 27.01.2024 under Section 19 (1) of the Right to Information Act, 2005 and received by the office of First Appellate Authority (FAA) on 11.09.2024 in connection with his application dated 21.12.2023 to provide information from Project Officer-cum-Assistant State Public Information Officer, Office of Additional Deputy Commissioner-cum - Chief Project Officer, Bhiwani.
2. The Appellant has informed that no information has been provided.
3. First Appellate Authority (FAA) directed the ASPIO, Bhiwani to provide the point wise desired information to the Appellant under intimation to this office by 24.09.2024 and personally appear on 26.09.2024 at 12.30 Noon with the information provided, if information is not provided or not satisfied with the information provided.
4. ASPIO-cum-PO, Bhiwani was present through online in hearing and informed that he has already supplied the information to the appellant vide letter no. 66 dated 01.02.2024 and No. 634 dated 19.09.2024 under intimation to appellant (Copy attached).
5. The Appellant did not appear on the said schedule nor he send any communication to this office.

6. Further one more opportunity have been provided to Appellant to appear before this office on 10.10.2024 at 11:30 AM but appellant did not appear. ASPIO-cum-PO, Bhiwani has joined online and again submitted the same reply to this office under intimation to the appellant and requesting that said RTI may be filed.
7. This office has carefully considered the application, the response, the appeal, and the records made available and finds that the matter can be decided based on the material available on record.
8. This office concurs with the submissions of the Respondent.

Order:-

In view of the above, the appeal stands disposed off and ordered accordingly. Copy of this order be sent to the appellant and ASPIO.

If the appellant is not satisfied with this order/ information provided, he/she may file an appeal before State Information Commission Haryana, SCO-70-71 (1st Floor), Sector-8, Chandigarh.
