- 3- The tenure of deputation shall be initially for 01 year.
- 4- The eligible and interested employee must apply through their parent department. The application must reach in HAREDA within 30 days from the date of issue of this circular. Applications sent directly will not be entertained.
- Only candidates who are not currently facing disciplinary action under Rule-7 or Rule-8 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016, or any judicial/vigilance proceedings (ongoing or contemplated), are eligible to apply. Additionally, there should be no adverse remarks regarding their integrity, and at least 70% of their Annual Confidential Reports (ACRs) must be rated as 'good' or above.

- 6- The parent department must ensure that the sponsored candidates are relieved w.e.f. if opportunities are provided for them to serve in the Haryana Renewable Energy Development Agency (HAREDA).
