Submission of a video(15-45 seconds) of installed Solar Pumps to district office and HQ under component-B of PMKUSUM scheme.

It is informed that during the review meeting held on 25.06.2025 regarding installation and monitoring of Solar Water Pumps under Component-B of PM-KUSUM scheme, it was decided that to ensure the quality and performance of installations, vendors must record a 15-45 second video for each pump installed under work orders issued during FY 2025-26.

The video must clearly display the farmer's name, address, vendor name and pumps category, pump installations features, water discharge, and micro-irrigation system (if applicable). The video must be submitted to the District Office before obtaining the signed Joint Commissioning Report (JCR), and also be submitted to Headquarters along with the payment claim for monitoring purposes in a pan drive.

The title/name of the video shall be the serial no. of the farmer in work order, Ist three alphabets of the vendor name and SARAL ID without mentioning SWPS. For example: a farmer is allocated to M/s Alpex Solar in a work order issued on 24.4.2025, he is at serial no. 1 and his SARAL ID is SWPS/2025/12345. Then the title/name of the video will be "0001ALP202512345"

In view of the above, you are hereby directed to complywith thesaid instructions and ensure submission of JCRs and payment claims in accordance with these guidelines for all work orders issued during FY 2025-26. The sample video and content are attached herewith for your reference.
