ORDER

1. The Appellant filed his first appeal under Section 19 (1) of the Right to Information Act, 2005 and which was received in this office on 18.06.2025.
2. The Appellant has informed that incomplete information has been provided.
3. First Appellate Authority (FAA) directed the SPIO, Yamunanagar to provide the point wise desired information to the Appellant under intimation to this office by 27.06.2025 and personally appear on 03.07.2025 at 12:30 PM with the information provided to applicant.
4. SPIO requested to join the hearing on 03.07.2025 through VC due to urgent official work at Yamunagar. Accordingly, the same was allowed.
4. The following were present on the date of the hearing:-

5. This office has carefully considered the application, the response, the appeal, and the records made available and finds that the matter can be decided based on the material available on record.


