Subject: Intimation for Non-Compliance of BEE Star Labelled Room Air Conditioner (Panasonic Model no. CS-ZU12XKYF/CU-ZU12XKYF)

Dear Sir/ Madam,

Contraction of the second seco

Pursuant to the provisions of Regulation 7 of the Bureau of Energy Efformery (Particulars and Manner of their Display on Labels of Room Air Conditioner) Regulations, 2017, the Bureau gave permission to M/s **Panasonic** India Pvt. Ltd. to affix label on the Room Air Conditioner, brand Panasonic, Model no. **CS-ZU12XKYF/CU-ZU12XKYF**.

The Bureau, under Regulation 11 of the Bureau of Energy Efficiency, (Particulars and Manner of their Display on Labels of Room Air Conditioner) Regulations, 2017, had purchased one samples of BEE Star Labelled RAC (Panasonic, Model no. CS-ZU12XKYF/CU-ZU12XKYF) and carried out check testing in accordance with the prescribed test procedures.

In pursuance of Regulation 11 (4) of the Bureau of Energy Efficiency Particulars and Manner of their Display on Labels of Room Air Conditioner) Regulations, 2017, the Bureau should conduct Second Check Testing of the failed model samples. Despite of various attempt to available the aforementioned models, it is found that Permittee has stopped the production of this model and hence the model are unavailable in the market as well as in manufacturing site. Due to this, it is impossible to conduct its second check testing.

In view of the above, the result of first check testing shall be treated as final and shall be binding on the permittee i.e., fail.

Pursuant to sub regulations (7) of regulation 11 of the Bureau of Energy Efficiency (Particulars and manner of their display on labels of Room Air Conditioners), Regulations, 2017, the permittee was directed to:

- a. Correct the star label displayed on the label of the household Room Air Conditioner or remove the defects and deficiencies found during testing;
- b. Withdraw all the stocks from the market to comply with the directions of the Bureau; and
- c. Change the particulars displayed on advertising material.

The permittee was directed to submit compliance report in the format as stated in form VII. The copy of report submitted by permittee is enclosed (Annexure A). Further, as per provisions of said regulation, the report is being submitted to the SDA for the purpose of ensuring action complied as per declaration of manufacturer in approved format under Section 17 of the EC Act, 2001. Therefore, you are requested to establish conformity and inform discrepancies, if any.

As already reported that, post the thorough checkups of our internal systems for market availability of respective model no unit of the mentioned model was found in the market earlier as well.
