ORDER

1. The Appellant filed his first appeal under Section 19 (1) of the Right to Information Act, 2005 and which was received online on 07.07.2025 in reference of RTI application no. 007649/2025 dated 16.05.2025 vide this application, appellant has informed that the provided information is incomplete, misleading or False.
2. The First Appellate Authority (FAA) directed the SPIO-cum- Scientific Engineer-A, HAREDA personally appear on 05.08.2025 at 12.05 PM PM with the information provided to applicant.
3. Accordingly, a hearing was fixed on 05.08.2025 at 12:05 PM to appear before the undersigned. But, the appellant failed to appear despite due notice and no communication and request for adjournment was received on behalf of the appellant. In the interest of justice and to provide a fair opportunity to be heard, it



was decided to grant one final opportunity to the appellant. Therefore, the hearing was re-fixed for 02.09.2025 at 12.00PM.

5. This office has carefully considered the application, the response, the appeal, and the records made available. It was informed to the FAA that the order in similar RTI has already been passed on dated 03.07.2025 in which the same information was sought.
