ORDER

1. The Appellant filed his first appeal under Section 19 (1) of the Right to Information Act, 2005 and which was received in this office on 17.10.2025.
2. First Appellate Authority (FAA) directed the SPIO-cum- Scientific Engineer-A, NRE and applicant to personally appear on 12.11.2025 at 12:30 PM with the information provided to applicant.
3. But, the applicant failed to appear despite due notice and no communication and request for adjournment was received on applicant behalf. But, in the interest of justice and to provide a fair opportunity to be heard, it is decided to grant one final opportunity to the applicant with the condition that if he fails to attend said hearing, the appeal will be disposed of. Accordingly, hearing was fixed for 02.12.2025 at 12:30 PM.
4. The following were present on the date of the hearing:-
 - a. Sh. Vishal Bhatnagar, SPIO-cum- Scientific Engineer-A, HAREDA.
 - b. Sh. Devender Kumar S/o Sh. Ram Kishan, VPO- Dhania, district-Rewari
4. The Appellant has informed that no information has been provided and requested to provide the complete information of his RTI application dated 06.08.2025

immediately. However, SPIO informed that the relevant information has already been provided to the appellant.

5. Therefore, the undersigned directed the SPIO-cum- Scientific Engineer-A, NRE to collect the sought information from the concerned and provide as early as possible to applicant. The SPIO required time to do the needful and requested to give one more hearing to have clarity of information sought and information already provided.
6. Accordingly, a hearing was fixed by ADC-cum-CPO, Rewari of the applicant and M/s Rotomag Motors and control Pvt. Ltd on 16.12.2025 at 12:30 PM to resolve the complaint of the applicant.
7. The FAA fixed another hearing on 30.12.2025 at 12.45 PM through VC. Sh. Vishal Bhatnagar, SPIO-cim-SE-A, HAREDA and Sh. Devender Kumar joined the hearing.
8. The Appellant has informed in said second hearing also that no information has been provided and requested to provide the complete information of his RTI application dated 06.08.2025 immediately.
9. Accordingly, SPIO, NRE was directed to provide the point wise information on all three points for which information was sought to the appellant within 10 days.
10. This office has carefully considered the application, the response, the appeal, and the records made available and finds that the matter can be decided based on the material available on record.

Order:-

In view of the above, the appeal stands disposed of and ordered accordingly. Copy of this order be sent to the appellant and SPIO, NRE. .

If the appellant is not satisfied with this order/ information provided, he/she may file an appeal before State Information Commission Haryana, SCO-70-71 (1st Floor), Sector-8, Chandigarh.
