ORDER

1. The Appellant filed his first appeal under Section 19 (1) of the Right to Information Act, 2005 to First appellate Authority, Mini Secretariat, Sirsa on 29.09.2025 and which was transferred to this office on 27.10.2025.
2. First Appellate Authority (FAA) directed the PO-cum-ASPIO, Sirsa, and applicant to attend the hearing on 30.12.2025 at 1:00 PM through VC .
3. The following were present on the date of the hearing:-
 - a. Sh. Sanjeev Nain, Project Officer -cum-ASPIO, Additional Deputy Commissioner-cum -Chief Project Office, Sirsa.
 - b. Sh. Inderjeet Adhikari, Rania Baar, Sirsa -125055.
4. The Appellant has informed that the information relating to point no.3, 4, 6, 7, 8, 9 & 10 is not provided to him and requested to provide the complete information of his RTI application dated 10.07.2025.
5. Therefore, the FAA directed the Project Officer -cum-ASPIO, O/o Additional Deputy Commissioner-cum -Chief Project Office, Sirsa to provide the information relating to point no. 3, 4, 6, 7, 8, 9 and 10 but he informed that requisite information is related to Supplies and Disposals Department, Haryana.
6. The First Appellate Authority directed the Project Officer -cum-ASPIO, Additional Deputy Commissioner-cum -Chief Project Office, Sirsa to transfer the said RTI to

Supplies and Disposals Department immediately as per the relevant provision of RTI act so that the required information's may be provided to the appellant and the appellant has agreed.

7. This office has carefully considered the application, the response, the appeal, and the records made available and finds that the matter can be decided based on the material available on record.

Order:-

In view of the above, the appeal stands disposed of and ordered accordingly. Copy of this order be sent to the appellant and SPIO, NRE. .
