As directed by the Hon'ble Board of Governors of Gujarat High Court Arbitration Centre and Hon'ble High Court Mediation Monitoring Committee, Gujarat State Legal Services Authority is going to undertake the process to select a Panel of Mediators for Med-Arb Centre of the Gujarat High Court Arbitration Centre and Gujarat High Court Mediation Centre. Therefore, applications are invited from the competent and interested Advocates and retired Judicial Officers in the cadre of District Judge. The applicant can directly send their application to the Member Secretary, Gujarat State Legal Services Authority, Ahmedabad through official mail Id - msguj.lsa@nic.in.

1. **Eligibility:** - The Following person can apply for the same.
 - A) Retired District Judges.
 - B) Advocates of Hon'ble Supreme Court / Hon'ble High Court who have experience of at least 10 years of advocacy.
 - C) The candidate should be the resident of Ahmedabad City.
 - D) Preference would be given to those Advocates/Retired Judicial Officers who are having experience/ specialization on Commercial and Arbitration matters.
2. **Place and the last date of submission of Application:**

The candidate holding eligibility may, in the prescribed format, submit their application personally in the office of the "Gujarat High Court Mediation Centre" 2nd Floor, GSLSA Building, Near Gujarat High Court Post Office, Gujarat High Court Campus, Sola, Ahmedabad-380060 or may send it through email at msguj.lsa@nic.in. The Format of the application can be downloaded from the websites of (1) Gujrat State Legal Services Authority (<http://gujarat.nalsa.gov.in>). (2) High Court of Gujarat (<http://gujarathighcourt.nic.in>) and (3) Gujarat High Court Arbitration Centre (<http://arbitrationgujhc.gujarat.gov.in>).

The application should reach to the above office on or before 30.01.2026, by 5.00pm latest. The applications submitted thereafter will not be considered.

3. **Attachment of self-attested copy of the documents with the application form:** With the application form, self-certified copy of all the documents in support of qualifications and experience should be included.
4. **Selection of Panel:** The applications received within prescribed time will be verified and the procedure as may be directed by the Hon'ble Board of Governors of Gujarat High Court Arbitration Centre and Hon'ble High Court Mediation Committee will be adopted.
5. For preparation of Panel of Mediators, as far as possible, the provisions of the Mediation Rules, 2015, prepared by Mediation and Conciliation Project Committee (MCPC) will be complied with.
6. Decision of the Hon'ble Board of Governors of GHAC and Hon'ble High Court Mediation Monitoring Committee for preparation of Panel of Mediators and to impart them training form Mediation and Conciliation Project Committee (MCPC), New Delhi will be considered as final decision.
7. **Training:** After initial scrutiny the selected Mediators have to undergo compulsory 40 hours Mediation Training imparted by the trainers of MCPC as per the curriculum laid down in Mediation Training Manual or as directed by Mediation and Conciliation Project Committee (MCPC). A self declaration for attending the said training, scheduled to be held during the period from 1st February, 2026 to 22nd February, 2026, have to be submitted by the selected mediators before the Gujarat State Legal Services Authority, along with the application form.
