Sub.: Declaration of Final NTA Scores for Joint Entrance Examination (Main) - 2025 for Paper 2A (B. Arch) and Paper 2B (B. Planning) – reg.

The Department of Higher Education, Ministry of Education, Government of India has entrusted the responsibility of conducting the Joint Entrance Examination (Main) to the NTA from 2019 onwards.

For Academic Session 2025-26, NTA has conducted the JEE (Main) -2025 for Paper 2A (B. Arch.) and Paper 2B (B. Planning) in two Sessions i.e Session 1 (January 2025) and Session 2 (April 2025).

The JEE (Main) - 2025 Session 2 Paper 2A (B. Arch) and Paper 2B (B. Planning) Examination was conducted on 09 April 2025 in one shift in 13 languages (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu) as under:

- B. Arch (Paper 2A) : Mathematics (Part-1) & Aptitude Test (Part II) in “Computer Based Test (CBT) mode and Drawing Test (Part-III) in Pen & Paper” (offline) mode.
- B. Planning (Paper 2B) : Mathematics (Part-I), Aptitude Test (Part-II) and Planning (Part III) in Computer Based Test (CBT).

The JEE (Main) – 2025 Session 2 was conducted at 531 unique examination centres in 300 Cities [including 15 cities outside India in Manama, Doha City, Dubai, Muscat, Riyadh, Sharjah, Singapore, Kuwait, Kuala Lumpur, Kathmandu, Abu Dhabi, West Java, Washington, Lagos and Munich].

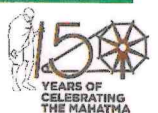

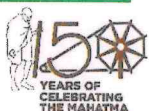


NTA Scores are normalized scores across multi-session papers and are based on the relative performance of all those who appeared for the examination in one session. The marks obtained are converted into a scale ranging from 100 to 0 for each session of examinees. NTA score is not the same as the percentage of marks obtained.

The NTA Score of a Candidate has been calculated as follows:

$$\frac{100 \times \text{Number of candidates appeared in the 'Session' with raw score EQUAL TO OR LESS than the candidate}}{\text{Total number of candidates who appeared in the 'Session'}}$$

After both Sessions of the JEE (Main) - 2025 Examination for Paper 2, the ranks of the candidates has been released taking into consideration the best of the two NTA Scores in accordance with the policy already made.

NTA thanks all the Central Government Agencies, State and District authorities, various exam functionaries and all the candidates for all the support extended during the successful conduct of the prestigious JEE (Main) 2025 Session 2.
