Subject: Declaration of Joint Entrance Examination [JEE (Main) - 2026] Session 1 NTA Scores for Paper 2 (B. Arch and B. Planning) – reg.

The National Testing Agency (NTA) conducted Joint Entrance Examination (Main)– 2026 Session 1 (January 2026) in **426 Centres in 316 Cities (including 12 cities outside India)** for Paper 2 (B. Arch and B. Planning) as per the details given below:

The JEE (Main) - 2026 Paper 2 (B. Arch & B. Planning) Examination was conducted on 29 January 2026 in one shift in **13 languages** (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu) as under:

- B. Arch (Paper 2A) : Mathematics (Part-1) & Aptitude Test (Part II) in “Computer Based Test (CBT) mode and Drawing Test (Part-III) in Pen & Paper (offline) mode”.
- B. Planning (Paper 2B) : Mathematics (Part-I), Aptitude Test (Part-II) and Planning (Part III) in Computer Based Test (CBT) Mode.

The Examination was also conducted in 12 cities outside India in **Manama, Doha, Dubai, Kathmandu, Muscat, Riyadh, Sharjah, Singapore, Kuwait City, Lagos, Washington and Abu Dhabi**.

NTA Scores are normalized scores across multi-shift papers and are based on the relative performance of all those who appeared for the examination in one shift. The marks obtained are transformed into a scale ranging from 100 to 0 for each shift of examinees. NTA score is not the same as the percentage of marks obtained. The NTA Score of a Candidate has been calculated as follows:

$$\frac{100 \times \text{Number of candidates appeared in the 'Shift' with raw score EQUAL TO OR LESS than the score of the candidate in the Shift}}{\text{Total number of candidates who appeared in the 'Shift'}}$$

The final rank of the candidates will be released taking into consideration the best of the two NTA Scores, after both Sessions of the JEE (Main)- 2026 Examination for Paper 2 in accordance with the policy already made.
