The date (s) and City of the examination have already been intimated to all the eligible candidates.

The candidates scheduled to appear on **02 and 04 April 2026** are required to download their Admit Card of **JEE (Main)–2026 Session-2 (April 2026)** from the website <https://jeemain.nta.nic.in/> w.e.f. **29 March 2026** and go through the instructions contained therein as well as in the Information Bulletin.


**Admit Cards for the candidates whose exams are scheduled on 05, 06, 07 and 08 April 2026 will be released in due course.**
