## Notification

**No. 781-Ft.-4-2020/3384.**— In exercise of the powers conferred by section 6 of the Wildlife (Protection) Act, 1972, the Governor of Haryana is pleased to reconstitute the State Board for Wildlife consisting of the following official and non-official members:

- The Headquarter of the Board will be at Panchkula. 2.
- The Board will function as per provisions laid down in the Wildlife (Protection) Act, 1972 and Wildlife (Protection) Harvana Rules, 1974.
- The Board will meet as and when required under the Chairmanship of the Chief Minister and in his absence the Minister-In-Charge/Secretary, Forests will preside over it.
- 5. The term of office of the members other than those who are members ex officio, will be for a period of 3 years.
- 6. The travelling allowance admissible to the non-official members will be as per the latest instructions of the Government. The non-official members will be allowed to avail T.A./D.A. as admissible to Grade-I employees of the Haryana Government.
  - The conditions laid down in the Haryana Civil Services T.A. Rules, 2016, as amended from time to (a) time, for Government employees, will also apply to journey performed by non-official members except where otherwise provided.
  - The travelling allowance for attending the meeting of the Board should be allowed to the members from their permanent places of residence to the place of meeting. If, however, a member attends a meeting from a place other than the place of his permanent residence, T.A. should be allowed to him either from the place of his residence or from where he attends the meeting, whichever is less.
  - The travelling allowance and D.A. will be admissible to the non-official members on the production of a certificate to the effect that no T.A. in respect of journey or D.A. for the period mentioned in the bill has been or will be claimed by him/her from any other official source.
- The T.A./D.A. admissible to the official members will be borne by their respective Departments.
- The expenditure on account of travelling allowance etc., of the non-official members of the Board will be met out from sanctioned budget of the Department under the Head "2406-Forestry and Wildlife".
- The Member Secretary of the Board shall be the controlling authority in respect of payment of allowances.
