OFFICE MEMORANDUM

Sub.: Constitution of the "Uttarakhand State Level Monitoring Committee" for overseeing the quality of Peoples Biodiversity Register (PBRs) in Uttarakhand.

Ref.: D.O. No. NBA/15/30/2019/SBB/NGT/2367, dated 08.11.2019 of the Chairman National Biodiversity Authority.

Section 41(1) of the Biological Diversity Act, 2002 states that, "Every local body shall constitute a Biodiversity Management Committee within its area for the purpose of promoting conservation, sustainable use and documentation of biological diversity including preservation of habitats, conservation of land races, folk varieties and cultivars, domesticated stocks and breeds of animals and microorganisms and chronicling of knowledge relating to biological diversity."

2. As per Rule 22(6) of the Biological Diversity Rules, 2004, the main function of the Biodiversity Management Committee is to prepare People's Biodiversity Register in consultation with local people. The Register shall contain comprehensive information on availability and knowledge of local biological resources, their medicinal or any other use or any other traditional knowledge associated with them. The People's Biodiversity Registers shall be maintained and validated by the Bio-diversity Management Committee.
3. People's Biodiversity Registers (PBRs)) are statutory technical documents that capture all the details of biological resources and associated knowledge available in the jurisdiction of the local body. Any person or entity accessing these biological resources or associated knowledge for research / bio-survey / bio-utilization / commercial utilization, are under obligation to share a portion of their benefit to the local communities to help in the conservation and sustainable availability of these resources.
4. Preparation of PBRs requires technical expertise at various stages. Compiling and collating the biological resources requires a comprehensive understanding of the subject matter. Therefore, a general awareness is required amongst local bodies for decision making in the use of biological resources available in their jurisdiction.
5. The Principal Bench of the Hon'ble National Green Tribunal vide Order dated 9th August 2019 in OA No. 347 of 2016 had issued instructions to constitute a monitoring Committee to oversee the quality of PBRs on sample basis by evolving a suitable mechanism.
6. Ministry of Environment, Forest and Climate Change vide Office Memorandum referred above, has constituted two Committees at the national level which will monitor the quality of PBRs.

7. The Committee would be as follows:-

9. The Monitoring Committee would have the following terms of references:
- To oversee the quality of PBRs on sample basis by evolving a suitable mechanism.
 - To interact with relevant stakeholders who are involved in the preparation of PBRs or as it deems fit.
 - To submit report to UBB every three months.
10. The UBB may amend the ToRs, if required.
11. The Guidelines for the committee shall be as referred to in Annexure-I

- To submit report to UBB every three months.


अभी तक राज्य के समस्त 7991 जैव विविधता प्रबन्ध समितियों के लिये PBRs की रचना secondary data के आधार पर हुई है। प्रत्येक जैव विविधता प्रबन्ध समिति के लिए PBRs का revision/upgradation/fine-tuning/ground-truthing and validation का कार्य को वृहद् स्तर पर accelerate किया जाना अत्यन्त आवश्यक है जिसके लिए 20 अतिरिक्त स्टॉफ (Interns) को सम्बद्ध किए जाने की प्रक्रिया भी शासन स्तर द्वारा अन्तिम चरण में है। Interns को तकनीकी प्रशिक्षण, Participatory Rural Appraisal (PRA) को जमीनी स्तर पर प्रभावी ढंग से लागू करना, Community mobilization, Socioeconomic development, Gender justice तथा PBRs हेतु जैव संसाधनों सम्बन्धित वृहद् स्तर पर जन जागरूक अभियान चलाना भी एक महत्वपूर्ण उद्देश्य है जिसके लिए अध्यक्ष, उत्तराखण्ड जैव विविधता बोर्ड, देहरादून के अनुमोदन के उपरान्त Uttarakhand State PBR Monitoring Committee में नामित सदस्यों के अतिरिक्त कुछ और अनुभवी और PRA में निपुण community resource persons को सम्मिलित किया जाता है। सदस्यों का विवरण निम्नलिखित हैं-


