Constitution of India.

No.RTR132000/273/CR108/SER II :- In exercise of the powers conferred by the proviso to article 309 of Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Chief Administrative Officer, Group-A and Administrative Officer, Group-B, in General State Services, in the Directorate of Health Services, under the Public Health Department of the Government of Maharashtra, namely, -

1. These rules may be called the Chief Administrative Officer, Group-A and Administrative Officer, Group-B, in Directorate of Health Services (Recruitment) Rules, 2002.

2. In these rules, unless the context requires otherwise,

a) "Commission" means the Maharashtra Public Service Commission;

b) "Degree" means a degree of a statutory university;

c) "Directorate" means the Directorate of Health Services, of Government.

d) "Government" means the Government of Maharashtra.

e) "Statutory University" means the University established by law for the time being in force.

3. Appointment to the post of Chief Administrative Officer, Group-A, in the Directorate shall be made either -

a) by promotion of a suitable person on the basis of seniority subject to fitness from amongst persons holding the posts of Administrative Officer, Group -B, in the Directorate, having not less than three years regular service in that posts; or

b) by nomination from amongst candidates who, -

i) unless already in the service of the Government, are not more than 40 years of age; and

ii) possess a degree or any other qualification recognised by the Government to be equivalent thereto; and

iii) possess executive or administrative experience or both, for a period of not less than seven years, gained after acquiring the qualification mentioned in sub clause (ii) above, in a Government Department, commercial concern, local authority or a corporation or board established by the Government; and

iv) have adequate knowledge of Marathi, so as to be able to speak, read and write the language with facility.

Provided that, the age limit may be relaxed by the Government on the recommendation of the Commission in favour of candidates with exceptional qualifications or experience or both.

Provided further that, preference may be given to candidates conversant with the rules, regulation and procedure relating to Government services matters, particularly the Maharashtra Civil Services Rules, the Financial Rules and accounting procedure and similar other rules regarding Government establishments.

4. Appointment to the post of Administrative Officer, Group-B in the Directorate shall be made either, -

a) by promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding the post of Superintendent, Accounts Superintendent, Accountant or Steward in the Directorate, having not less than three year's regular service in those posts; or

b) by nomination from amongst candidates who, -

i) unless already in the service of the Government, are not more than 35 years of age;

ii) possess a degree or a qualification recognised by the Government to be equivalent thereto; and

iii) possess experience in office administration for a period of not less than five years of which at least three years experience should be in a supervisory capacity in a post comparable to that of Superintendent or Head Clerk under Government or under a Local Authority or Commercial establishment or a Corporation or Board established by Government; and

iv) have adequate knowledge of Marathi, so as to be able to speak read and write the language with facility.

Provided that, the age limit may be relaxed by the Government on the recommendation of the Commission in favour of candidates having exceptional qualifications or experience or both.

Provided further that, preference may be given to candidates conversant with the rules, regulation and procedure relating to Government services matters, particularly the Maharashtra Civil Services Rules, the Financial Rules and accounting procedure and similar other rules regarding Government establishments.

5) Appointment to the post of Chief Administrative Officer, Group-A and Administrative Officer, Group-B mentioned in rules 3 and 4 by promotion and nomination, shall be made in the ratio of 50:50 respectively.

6) A person appointed to the posts mentioned in rules 3 and 4 shall be on probation for a period of two years.

Provided that, the probation period may be extended for one more year & the services of the person appointed shall be liable to terminated if -

I) he does not pass the examination mentioned in rule 7, unless he has been exempted from passing those examinations; or

II) his work is found unsatisfactory.

7) A person appointed to the posts mentioned in rules 3 and 4, whether by promotion or nomination, shall be required,-


(a) to undergo such courses or pass such examinations, or both, as may be prescribed, from time to time; and

(b) to pass examinations in Hindi and Marathi according to the rules made in that behalf unless he has already passed or has been exempted from passing those examinations.

8) Persons appointed to the posts mentioned in rules 3 and 4 should possess a certificate in computer operation prescribed by the Director of Information and Technology, Government of Maharashtra for time to time.

9) A person appointed to the post mentioned in rules 3 and 4 shall be liable for transfer anywhere in the state of Maharashtra.



No.RTR102000/CR.108/SER-II In exercise of the power conferred by the proviso to article 309 of Constitution of India and in supersession of all existing rules, orders or instruments made in this behalf the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Chief Administrative Officer, Group-A and Administrative Officer, Group-B in General State Services in the Directorate of Health Services of the Govt. of Maharashtra, namely,

1. These rules may be called the Chief Administrative Officer, Group-A and Administrative Officer, Group-B in Directorate of Health Services (recruitment) Rules 2000.

2. In these rules, unless the context requires otherwise,

a) "Commission" means the Maharashtra Public Service Commission.

b) "Degree" means a degree of a statutory university.

c) "Directorate" means Directorate of Health Services, Mumbai.

d) "Government" means the Government of Maharashtra.

e) "Statutory University" means the University established by law for the time being in force.

3. Appointment to the post of Chief Administrative Officer, Group-A in the Directorate shall be made by promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding the

posts of Administrative Officer, Group-B in the same Directorate who have put in not less than three years regular service in that post.

4. Appointment to the post of Administrative Officer, Group-B in the Directorate shall be made either,-

a) by promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding the posts of Supdt., Accounts Supdt., Accountant and Steward in the same Directorate, having not less than three years regular service in those posts, or

b) by nomination from amongst candidates who,-

i) Unless already in the service of the Government, are not more than 35 years of age.

ii) Possess degree of statutory University or a qualification recognised by Government as equivalent thereto, and

iii) Possess experience in office administration for a period of not less than 5 years of which at least 3 years experience should be in a supervisory capacity in the in a post comparable to that of superintendent or Head Clerk under Government or under Local Authority or Commercial Establishment or Corporation or Board Established by Government and

iv) have adequate knowledge of Marathi, so as to be able to speak, read and write the language with facility.

Provided that the age limit may be relaxed by the Government on the recommendation of the Commission in favour of candidates with exceptional qualifications or experience or both.

Provided further that preference may be given to candidates conversant with the rules and procedure relating to Government service matters and regulations particularly Maharashtra Civil services Rules, the

financial Rules and Accounts procedure and similar other rules regarding Government Establishment.

5) Appointment to the post of Administrative Officer, Group-B mentioned in rule 4 by promotion and nomination, shall be made in the ratio of 50:50.

6) A person appointed to the post mentioned in rule 4, by nomination, shall be on probation for a period of two years. Probation period may be extended one year only. If he could not clear probation successfully within prescribed period, or could not pass or exempted from passing the examination mentioned in rule 7, or did not found suitable for the post, will be liable to terminate from service without prior notice.


7) A person appointed to the posts mentioned in rules 3 and 4, whether by promotion or nomination, shall be required,-

(a) to undergo such courses or pass such examinations, or both, as may be prescribed from time to time, and

(b) to pass examination in Hindi and Marathi according to the rules made in that behalf unless he has already passed, or has been exempted from passing, those examinations.

8) A person appointed to the above posts shall be liable for transfer anywhere in the state of Maharashtra.

क्र.आरटीआर १३२०००/२७३/प्र.क्र.१०८/सेवा -२ :- भारताच्या संविधानाच्या अनुच्छेद ३०९ च्या परतुकान्वये प्रदान करण्यात आलेल्या शक्तींची वापर करून सद्या अस्तित्वात असलेले सर्व नियम, आदेश व अमुदेश निष्प्रभावी करून महाराष्ट्राचे राज्यपाल याद्वारे महाराष्ट्र शासनाच्या आरोग्य सेवा संचालनालयातील सामान्य राज्य सेवा मधील मुख्य प्रशासकिय अधिकारी गट-अ व प्रशासकिय अधिकारी गट-ब या पदाच्या सेवा भरतीचे विनियमन करणारे पुढील नियम करीत आहेत, जसे :-

१. या नियमांना आरोग्य सेवा संचालनालयातील " मुख्य प्रशासकिय अधिकारी गट-अ व प्रशासकिय अधिकारी गट-ब ( सेवा प्रवेश ) नियम, २००२ " असे संबोधण्यांत यावे.

२. या नियमामध्ये संदर्भानुसार दुसरा अर्थ अपेक्षित नसेल तर :-

- अ) "आयोग" म्हणजे महाराष्ट्र लोकसेवा आयोग,
- ब) "पदवी" म्हणजे सांविधिक विद्यापीठाची पदवी,
- क) "संचालनालय" म्हणजे महाराष्ट्र शासनाचे आरोग्य सेवा संचालनालय,
- ड) "शासन" म्हणजे महाराष्ट्र शासन.
- इ) "संविधानिक विद्यापिठ" म्हणजे अस्तित्वात असलेल्या कायद्यानुसार स्थापित केलेले विद्यापिठ.

३. संचालनालयांतर्गत मुख्य प्रशासकिय अधिकारी गट-अ या पदावर करावयाची नेमणूक पुढील पैकी कोणत्याही एका प्रकारे करता येईल-

अ) संचालनालयामधील प्रशासकिय अधिकारी गट-ब या पदावर काम करीत असलेल्या व त्या संवर्गात किमान ३ वर्षे नियमित सेवा केलेल्या व्यक्तीमधून जेष्ठता अधीन पात्रता या आधारे पदोन्नती देऊन नेमणूक करता येईल, किंवा

ब) ज्या उमेदवाराच्या बाबतीत पुढील शर्ती पूर्ण होत असतील अशा व्यक्तीमधून नामनिर्देशनाने करता येईल:-

(एक) अयोदय शासन सेवते असलेल्या व्यक्ती करून ज्यांचे वय ४० वर्षांपेक्षा जास्त नसेल

आणि

(दोन) साविधीक विद्यापीठाची पदवी किंवा शासनाने तिच्याशी समतुल्य मान्यता देऊन कोणत्याही अर्हता धारण करीत आहे आणि

(तीन) वरील उपखंड (दोन) मध्ये नमूद केलेली शैक्षणिक अर्हता संपादन केल्यानंतर शासकीय सेवेत किंवा शासनाने स्थापन केलेल्या स्थानिक प्राधिकरणात, महामंडळे किंवा मंडळांमध्ये कार्यकारी किंवा प्रशासकीय किंवा दोन्ही प्रकारच्या कामाचा अनुभव किमान सात वर्षे धारण केलेला असावा. आणि

(चार) लिहीता, वाचता व बोलता यावे इतके मराठी भाषेचे पुरेसे ज्ञान असावे.

परंतु असे की, विहित केलेली कमाल वयोमर्यादे संबंधीची शर्त ही, असाधारण अर्हता किंवा अनुभव किंवा दोन्हीही धारण करणाऱ्या उमेदवारांच्या बाबतीत शासन आयोगाच्या शिफारशीनुसार शिथिल करू शकेल.

परंतु आणखी असे की, शासकीय सेवेसंबंधीचे नियम, पध्दती तसेच महाराष्ट्र नागरी सेवा नियम, वित्तीय नियम व लेखा पध्दती आणि शासकीय आस्थापनेशी संबंधित नियमांचे ज्ञान असलेल्या उमेदवारास प्राधान्य दिले जाईल.

४. संचालनालयामधील प्रशासकिय अधिकारी गट- ब या पदावर करावयाची नेमणूक पुढील पैकी कोणत्याही एका प्रकारे करता येईल,-

अ) संचालनालयामधील अधीक्षक, लेखा अधीक्षक, लेखा पाल व कारभारी या पदावर काम करीत असलेल्या व्यक्तींच्या एकत्रित जेष्ठतेनुसार व किमान त्यासंबर्गात तीन वर्षे नियमित सेवा केलेल्या व्यक्तींमधून जेष्ठता अधीन पात्रता या आधारे पदोन्नती देवून नेमणूक करता येईल, किंवा

ब) ज्या उमेदवारांच्या बाबतीत पुढील शर्ती पूर्ण होत असतील अशा व्यक्तींमधून नामनिर्देशनाने करता येईल,-

(एक) अगोदरच शासन सेवेत असेल त्या खेरीज करून ज्याचे वय ३५ वर्षांपेक्षा जास्त नसेल.

(दोन) साविधीक विद्यापीठाची पदवी किंवा शासनाने तिच्याशी समतुल्य म्हणून जाहीर केली अन् कोणतीही अर्हता धारण करीत आहे आणि

(तीन) शासकीय सेवेत किंवा शासनाने स्थापित केलेल्या स्थानिक प्राधिकरणांमध्ये किंवा व्यापारविषयक आस्थापनेमध्ये किंवा महामंडळांमध्ये किंवा मंडळांमध्ये कार्यालयीन प्रशासनाचा कर्म करी पाच वर्षांचा अनुभव, यामध्ये अधीक्षक किंवा मुख्य लिपिक स्तरावरील पदांचा परिवर्तन स्वतःचा किमान तीन वर्षांचा अनुभव असावा. आणि

५. नियम ३ आणि ४ मधील मुख्य प्रशासकीय अधिकारी गट अ आणि प्रशासकीय अधिकारी गट ब या पदावर पदोन्नतीद्वारे आणि नामनिर्देशनाद्वारे करावयाच्या नेमणूकीचे प्रमाण अनुक्रमे ५०:५० असे राहील.

६. नियम ३ आणि ४ मधील पदावर नियुक्त झालेली व्यक्ती दोन वर्षांच्या कालावधीपर्यंत परिवीक्षाधीन राहील.

परंतु असे की, सदर परिवीक्षाधीन कालावधी एक वर्षापर्यंत वाढविता येईल आणि नियुक्ती दिलेली व्यक्ती खालील कारणामुळे सेवा समाप्त करण्यास पात्र राहील, जर

अ) त्यांनी नियम ७ मध्ये नमूद केलेल्या परीक्षा उत्तीर्ण केल्या नाहीत, किंवा सदर परीक्षा उत्तीर्ण होण्यापासून त्यांना सूट देण्यात आलेली नाही, किंवा

ब) त्यांचे काम असमाधानकारक असल्याचे आढळून आल्यास.

७. नियम ३ किंवा ४ मधील पदावर पदोन्नतीने किंवा नामनिर्देशनाने नेमणूक झालेल्या व्यक्तीस,-


अ) वेळोवेळी विहित केलेले प्रशिक्षण घ्यावे लागेल किंवा विहित परीक्षा उत्तीर्ण व्हावी लागेल किंवा दोन्ही आणि,

ब) या परीक्षापूर्वीच उत्तीर्ण झाली नसेल अथवा या परीक्षा उत्तीर्ण होण्यापासून सूट मिळालेली नसेल तर त्याबाबतीत विहित केलेल्या नियमानुसार मराठी व हिंदी भाषा परीक्षा उत्तीर्ण होणे आवश्यक असेल.

८. नियम ३ किंवा ४ मधील पदावर नेमणूक झालेल्या व्यक्तीने संचालक, माहिती व तंत्रज्ञान, महाराष्ट्र शासन यांनी वेळोवेळी विहित केलेले संगणक हाताळणीचे प्रशिक्षण घेतलेले असावे.

९. नियम ३ किंवा ४ मधील या पदावर नियुक्त झालेली व्यक्ती महाराष्ट्र राज्यामध्ये कोठेही बदलीस पात्र असेल.

# प्रशासकीय अधिकारी कलिय व सबाबदाया

## DUTIES AND RESPONSIBILITIES OF ADMINISTRATIVE OFFICER

01. To be incharge of lay administration of Offices, Hospitals, Medical Colleges where ever they may be posted.
02. To perform duties of drawing and disbursing officer of the institution to which they are posted.
03. To deal with accounts matter.
04. To be responsible for each transactions of the institutes, where they are posted.
05. To be responsible for the service matters of the persons working in the institution.
06. To be responsible to the audit compliance, disposal of audit notes work. and compliance of the store verification reports.
07. To be responsible for the budgetary control of the institution.
08. To be responsible to the Head of the institution in charge of their duties.
09. To supervise over the personnel of the concerned Desk/Office.
10. To be responsible for the disposal of non professional and routine correspondence of the hospital/institution/office.
11. To watch the progress in expenditure of the institution with reference to relative budget grants.
12. To ensure that the expenditure initially incurred from the Zilla Parishad funds is reimbursed too promptly as possible when posted to the D.F.W.C.
13. To ensure that all stocks and supplied are properly stores and accounted for and supply line is maintained through the year when posted to D.F.W.C.
14. To carry out physical verification of stock and stores and ensure that all the stock is properly utilised without allowing any article to occur.
15. To ensure that necessary indents for supply of articles are placed in good time and supplies secured promptly so that the work does not suffer.
16. To be responsible for the custody and the maintenance of all vehicles.
17. To be responsible for the custody and the maintenance of accounts of the permanent advance sanctioned for the sterilizations and IUCD performances. He should ensure prompt settlement of claims for sterilisation operation and continuous flow of amounts from permanent advance from the Dist Head Quarter up to Primary Health Centres levels and arrange for prompt and timely repayments of the permanent advance.
