**प्रस्तावना :-**

शासनाकडून जनतेला देण्यात येणाऱ्या सुविधा जलदगतीने विनासायास आणि किफायतशीरपणे देण्यात याव्यात या करिता, मंत्रालयीन विभाग आणि त्यांच्या नियंत्रणाखालील क्षेत्रीय कार्यालये, मंडळे, महामंडळे यांनी ई-गव्हर्नन्सचा जास्तीत जास्त वापर करावा; त्यासाठी प्रत्येक मंत्रालयीन विभागांनी सन २०१०-११ पासून त्यांच्या योजनेतर आणि योजनांतर्गत एकुण तरतुदीच्या अर्धा टक्का इतक्या निधीची तरतुद ई-गव्हर्नन्स करिता करण्याच्या सूचना क्र. २ वरील संदर्भाधीन शासन निर्णयान्वये देण्यात आलेल्या आहेत.

नागरिकांना देण्यात येणाऱ्या ई-सुविधांची यादी संदर्भाधीन शासन निर्णयाच्या परिच्छेद (क) मध्ये नमुद केल्याप्रमाणे परिशिष्ट "अ" मध्ये दिलेली आहे.
