1. eGovernance Training and Certification as case study

Government of Maharashtra is one of the "Leader" states in India, for its leadership position in eGovernance projects. DIT, Government of Maharashtra has announced in eGovernance Policy in 2011. Government of Maharashtra is currently implementing more than 300 e-Governance projects across various state departments. In order to ensure successful implementation of these initiatives and sustained development of e-Governance in the line departments, it is necessary to create strong IT teams across all stakeholder areas. To quickly address the training and capacity building needs, DIT, under leadership of Secretary (IT), Shri Rajesh Aggarwal formulated this unique initiative of online training and certification for all stakeholders working in eGovernance domain in Maharashtra as well as at National level.

This case study describes this unique project of DIT, called "eGovernance Training and Certification". This project has website https://egovtraining.maharashtra.gov.in

2. Project Context

This project is first and unique online certification programme, for anybody working in the field of eGovernance. Anybody can apply for this certification free-of-cost. More detail about this initiative is provided in the case study.

4. Uniqueness of the project

This project is very unique kind of project in India. It is the ONLY training and certification initiative in India, for eGovernance Domain, available FREE-OF-COST to participant in online manner. The entire process is online and the certificates are also delivered through email to the successful candidates.

5. Methodology adopted for case writing

The authors are the primary source of the information. They are the key project drivers and instrumental in driving this project since its inception. The statistics are source from the candidates for all batches of the egovernance training and certification. More over feedback from candidates and other stakeholders was collected through email and personal interviews. This project has won two awards viz. Skotch Order of Merit Award and CSI-Nihilent Award this year. Project Presentation delivered during those award selection process are also referred here.

1. Abstract

This case study describes a very unique and innovative initiative from Directorate of Information Technology, Government of Maharashtra, for online training and certification in eGovernance Domain. This project has website called <u>egovtraining.maharashtra.gov.in</u>, where any candidate can register and appear for this online examination, free-of-cost.

2. Keywords

3. Note for Practitioners

It was learnt that the standard courses available for the topics of "eGovernance" were of theoretical type. They did not have that practical edge, that is required in to work practically in egovernance domain at state/central government level. This case study highlights a unique project initiative by Directorate of Information Technology, Government of Maharashtra to address above challenges and bridge the knowledge and experience gap.

Entire project design, including the course material, question paper-sets, Examination Methodology and Evaluation/Grading methods were designed in a specific way to address these issues.

The key take-away from this case study is the uniqueness of this project and its ability to replicate itself for any other state or organisation. This project employs some of the best methodologies and tools for candidate training, assessment and rewards.

4. Stakeholders for the project

This programme is open to everyone working in the field of eGovernance. Moreover, it is noticed that the important stakeholders can be categorised as follows:



5. Objectives of Training process

This programme aims to facilitate learning of basic and fundamental concepts of e-Governance with practical scenarios.

The exam checks the fundamental/practical knowledge grasped by the candidate. Rather than theoretical concepts and examples, this programme stresses upon practical knowledge. The focus is not on mugging up definitions, but understanding of concepts and being able to appreciate and apply them in real project scenarios.

6. Project Overview

eGovernance Training and Certification" is the first and only ONLINE certification course in e-Governance in India, managed by Directorate of Information Technology (DIT), Govt. of Maharashtra. It is open to all, at national and International level. This unique certification programs tests an individual's skill and knowledge on e-Governance. This programme aims to facilitate learning of basic and fundamental concepts of e-Governance with practical scenarios. Its objective to test the fundamental/practical knowledge grasped by the candidate, rather than mugging of definitions etc.

Evaluation Methodology

Three-stage evaluation process is followed for this examination:

- 1. Online objective Q&A
- 2. Online subjective Q&A
- 3. Personal/Face2Face interview (though video-chat or in person)

Reward Process

All successful candidates (Pass, Distinction and Mentor categories) are awarded a Certificate Of Achievement for the course. Mentor Title is granted to exceptional candidates as described above. Mentors and Distinction candidates are awarded with Cash prize too, from DIT, Government of Maharashtra.

7. Business Process Reengineering

As indicated earlier, this is online training course. The approach in this project/training process is RADICALLY different than traditional egovernance courses being offered elsewhere.

The following important processes related to conventional egovernance training were re-engineered for this project:

(A) Online Training

Rather than classroom style training, here, reading material and links of important sites are also provided on above website, which would facilitate learning of basic and fundamental concepts of e-Governance with practical scenarios. Apart from the reading material available on this page website, links for additional reading material is mentioned in the online question paper.

(B) Online Examination

The examination process is online, in three stages, Online objective Q&A, Online subjective Q&A and Personal/Face-to-Face interview (though video-chat or in person)

(C) Use of cloud services

The registration process and online examination process (test attempts, evaluation, results etc) is done using cloud services.

(D) Use of Mentors

All candidates with excellent understanding of eGovernance principles and domain knowledge, who score very high as per grading criteria specified above, are selected as mentor. A team of "Mentors" is built in this process, as project progresses, thus helping DIT, to further propagate and enhance the project.

Contribution from Mentors

- Mentors also guide prospective candidates.
- They take part in the evaluation process.
- They also build and expand the question bank.

8. Progress so far

Since the start of the project in October 2012, eight batches of certification is completed. Over 3000 participants registered in the project. 300+ candidates have been certified till now.

The website is Google TOP RANKER for the keyword search "eGovernance Training and certification". The website has approximately 25000+ visits till now.

9. Challenges in Implementation

As such, there were no technical challenges faced for implementing above changes, as we had selected right kind of tools and technologies. Also the changes were easy to be accepted by all stakeholders.

10. Key Achievements and Benefits

This programme has become widely popular initiate in Maharashtra and at National Level.

Key Achievements

- Participation by candidates from all over India as well as foreign countries (from USA/Africa etc)
- Immense improvement in knowledge base of participating candidates
- Improvements in quality of the project work being executed by successful candidates, due to better knowledge dissemination
- Early and effective adaptation of newer technologies in some of the egovernance projects of Government of Maharashtra

The candidates, who have gone through this certification process, are the REAL BENEFICIARY of LEARNING process! They have greatly appreciated the training and evaluation methodology. Some of them have even started to use similar approach in their organisation/company to evaluate their staff working in eGovernance Domain.

Efficiency and Improvement in eGovernance Projects

It has saved time and effort for identification/selection of egovernance project resources within government departments as the candidates with "eGov certification" can be selected right away, as DIT has done "testing" of these resources.

Noticeable improvements in quality of the project work being executed by successful candidates have also been reported, as their knowledgebase has increased.

There has been early and effective adaptation of newer technologies in many egovernance projects of Government of Maharashtra, due to wide variety of subjective/topics chosen for drafting of question papers.

11. Key Lessons learned

The choice of technology and the implementation strategy was perfect fit for success of this project. The improvement seen by all stakeholders who have participated in the projects is visible through the sample feedback and interviews conducted. The maintenance of the question bank and guidance to candidates was done by mentors to the optimal level. The online interview process is also smooth and effective through use of online video conferencing/chatting tools.

12. Change Management and Capacity Building

This project has adopted a set of unique change management and capacity building steps, to ensure success and sustenance of the project over longer time-frame. These are highlighted below.

Leadership support

This project has full support from Leadership of all stakeholders. Secretary (IT), who has created blue-print of the project, monitors the project on regular basis. DIT officials also take active part in the project initiatives

Capacity building strategy

The team of mentors, created during the project process, becomes part of the capacity building exercise and further propagates the project.

Sustainability

As described above, the team of mentors makes the project sustainable. The process is institutionalized within DIT, GoM.

Financial Support

This project is self-funded (i.e. funded by DIT). Due to use of cloud services, the infrastructure cost is negligible.


Technology Solution Used

The project uses cloud technology for major modules of the examination process. It uses a third-party cloud solution for registration of candidates. It uses a very popular MOOC platform <u>www.classmarker.com</u> for online assessment, grading, results etc.

All information for this examination is maintained as secured and confidential; including papers etc though use of proper login credentials of classmarker platform.

14. Value Indicators

The Value Indicators are high level goals and objectives which can be used as guiding philosophies for defining visionary scenarios within which to place e-Governance projects.

Digital Inclusion

Language, demographic and Cultural differences may result in certain types of stakeholders not getting fully benefitted from e-Governance initiatives. This project aims to bridge that gap, by providing quality training about egovernance in online method, so that everybody can learn about egovernance.

Capacity Building

Through this unique initiative, the capacity building of all participants working in eGovernance field takes place more effectively and at faster pace. It also brings standardisation in knowledge dissemination, though use of same study material and tools across all batches.

Green e-Governance

This project also qualifies for Green e-Governance initiative as it does away with conventional (paper consuming) method of examination assessment using paper and pen/pencil. Here everything is online. Even the certificate to each successful candidate is sent online in PDF form (print copy is not given).

Within ONE year of its operation, this project has won two awards. These awards are:

16. Future Enhancements and Way ahead

This training and certification programme shall become integral part of Virtual IT Cadre initiatives of Govt of Maharashtra. Improvements planned

- Larger question bank
- Automated certification (with only objective papers)
- Paid registration for specialized certification (UID, DBT, Localization, Accessibility etc)

DIT is also proposing collaboration with NeGD to take this to the national level, to have standardized training and certification platform

In the next phase of this project, the following variations/modular certification is planned

There will be two types of certification process:

- First variety : Free certification will offer objective type of testing and online certification generation
- Second Variety : This will be PAID option, where candidate can pay online fee (say Rs 500) and appear for objective as well as descriptive (subjective testing)

Specialised modules in specific areas of egovernance (e.g. UID, DBT, Localisation etc) would also be offered.

Replicability of the project

With this innovative idea and modular design of course material; different modules and paper-sets can be made available for different categories of candidates. Thus, it can also be replicated in universities, training institutes etc.
