ADMISSION NOTICE

Fresh Admission for Class X and XII only (Session 2026–27)

Applications are invited for admission in Class X and XII (**Commerce and Humanities Stream**) to fill a few vacant seats in PM SHRI Kendriya Vidyalaya Vikaspuri, Shift–2.

1. These vacancies are available only for wards of:

- a) **Transferable and Non-Transferable Central Government Employees and Ex-Servicemen (Category–1)**
- b) **Transferable and Non-Transferable Employees of Autonomous Bodies/Public Sector Undertakings/Institutes of Higher Learning of Government of India (Category–2)**

The registration form is to be submitted **offline only** along with self-attested copies of required documents in the Vidyalaya.

2. Registration Dates:

From 29.05.2026 to 02.06.2026

Timing for submission of registration form - 10:00 AM to 1:00 PM.

Interested and eligible parents may submit the duly filled registration forms latest by 02nd June 2026 till 01:00 PM in offline mode along with all required documents.

3. Eligibility Criteria

- a) The student must have been studying in the same stream/course in a CBSE affiliated school.
- b) The student must have secured a minimum of 55% marks in the Class IX / XI Annual Examination in the same stream.
- c) The student must possess CBSE Registration in Class IX / XI as per CBSE norms and guidelines.
- d) The student should otherwise be eligible as per KVS Admission Guidelines 2026–27.
- e) Admission will be considered only if the subject combination opted by the student is available in the Vidyalaya.
- f) Admissions will be granted strictly on the priority order of service categories of parents as per KVS Admission Guidelines 2026–27 (Only Category 1 & 2).
