<b>g) Note:</b>	
	1. Mere Registration will not confer a right to admission.
	2. Incomplete application forms shall normally be rejected.
	3. Admission secured on the basis of wrong certificate shall be cancelled by the principal forthwith and no appeal against such action of the principal shall be entertained.
	<b>4. Contact Principal/ Admission in charge and committee members only when called, in the given time slot.</b>

This will further be subject to the following conditions:

- The child has been in the same course of studies i.e. in a CBSE affiliated school.
- For Class X, the child must have obtained not less than 55% marks in aggregate in class IX.
- For admission to class XII, 55% marks in class XI examination is mandatory.
- The child should otherwise be eligible as per KVS Admission Guidelines.
- The combinations of subjects opted by the student are available in the concerned Kendriya Vidyalaya.
- Fresh Admission will be for Priority category I and II for Civil and Defence sector KVs and priority category I to III in case IHL/Project sector KVs only.
