

d) <b>Minimum/ Maximum Age of child for admission (to be calculated as on 31 March 2026)</b>	<ul style="list-style-type: none"><li>• Class-X- 14 years but less than 16 years of age</li><li>• Class-XII- There will be no upper &amp; lower age limit for admission to class XII provided there has been no break in the continuous study of the student after passing class XI.</li></ul>
e) <b>List of documents required for issue of registration form</b>	Birth Certificate of child issued by competent authority. <b>(Bring Original Certificate).</b>
f) <b>List of documents to be attached with registration form ( self attested copy)</b>	<ol style="list-style-type: none"><li>i) Birth Certificate of child issued by competent authority.</li><li>ii) Residence Proof (local)</li><li>iii) Quarter Allotment Letter (for Govt employee only)</li><li>iv) Service Certificate of parent showing number of transfers during the preceding 7 years (for Govt. employees only) duly signed and stamped by Head of the Office bearing the name, Designation and other relevant particulars in Block Letters.</li><li>v) Caste Certificate of child (if any) issued by competent Authority.</li><li>vi) ID Proof of parents.</li><li>vii) Aadhar Card of parents and child.</li><li>viii) Blood Group Report of child</li><li>ix) 02 x Passport Size Photo of child.</li></ol>
g) <b>Note:</b>	<ol style="list-style-type: none"><li>1. Mere Registration will not confer a right to admission.</li><li>2. Incomplete application forms shall normally be rejected.</li><li>3. Admission secured on the basis of wrong certificate shall be cancelled by the principal forthwith and no appeal against such action of the principal shall be entertained.</li><li>4. <b>Contact Principal/ Admission in charge and committee members only when called, in the given time slot.</b></li></ol>

This will further be subject to the following conditions:

- a) The child has been in the same course of studies i.e. in a CBSE affiliated school.
- b) For Class X, the child must have obtained not less than 55% marks in aggregate in class IX.
- c) For admission to class XII, 55% marks in class XI examination is mandatory.
- d) The child should otherwise be eligible as per KVS Admission Guidelines.
- e) The combinations of subjects opted by the student are available in the concerned Kendriya Vidyalaya.
- f) **Fresh Admission will be for Priority category I and II for Civil and Defence sector KVs and priority category I to III in case IHL/Project sector KVs only.**
