



g) Note:	<ol style="list-style-type: none">1. Mere Registration will not confer a right to admission.2. Incomplete application forms shall normally be rejected.3. Admission secured on the basis of wrong certificate shall be cancelled by the principal forthwith and no appeal against such action of the principal shall be entertained.4. The address entered and the address proof submitted by the parent during the application process shall be treated as final for determining the neighborhood. No request for change of address will be entertained for this purpose, except in cases of government employees shifting to government accommodation, after the lists of provisional admissions are out5. Contact Principal/ Admission in charge and committee members only when called, in the given time slot.
