ADMISSION NOTIFICATION FOR CLASSES 2 TO 12 (Except classes 3,11) SESSION 2026-27

It is here by informed that as of now a few vacancies are available in classes 6 and 7.

The Vidyalaya is inviting applications for other classes to maintain list of interested candidates, so that as and when the vacancies arise the candidates will be called for admission as per the KVS admission guidelines.

Admissions will be carried out strictly in accordance with the **Kendriya Vidyalaya Sangathan (KVS) Admission Guidelines 2026–27**.

1. Vacancy Position

- **CLASS VI** - 01 Seats (Subjected to the availability of seats on the day of declaration result)
- **CLASS VII** -01 Seats (Subjected to the availability of seats on the day of declaration result)

3. Eligibility

- The applicant must have successfully passed the preceding class from a recognized school.
- Admission will be granted based on **priority category, reservation norms, and availability of seats**.

2. Report Card of the last class passed
3. Proof of Date of Birth
4. Caste/Category Certificate (if applicable)
5. Service Certificate (for Govt./Defence employees, if applicable)
6. Aadhaar Card

- Mere registration does not guarantee admission.
- Incomplete or incorrect applications will be **summarily rejected**.
- Admissions will be finalized as per **KVS rules and priority categories**.

4. ELIGIBLE AGE FOR ADMISSION

A Child must be **6 years old for Class-I** as on 31st March in the academic year in which admission is sought (**Child born on 1st April should also be considered**). The minimum and maximum age limit for admission in Kendriya Vidyalayas in various classes is given below:

Class	Minimum / Maximum Age as on 31st March of the Year in which admission is sought.
Class -I	6 years but less than 08 years of age
II	7 years but less than 09 years of age
III	8 years but less than 10 years of age
IV	9 years but less than 11 years of age
V	10 years but less than 12 years of age
VI	10 years but less than 12 years of age
VII	11 years but less than 13 years of age
VIII	12 years but less than 14 years of age
IX	13 years but less than 15 years of age
X	14 years but less than 16 years of age

Note:

- i. Consequent upon the change in the minimum and maximum age for admission, introduced for Class I in the session 2022-23, progressive change in the age limits for the appropriate classes will be continued in future too.
- ii. The maximum age limit may be relaxed by two years in case of Children with Special Needs (CwSN).
- iii. There is no age restriction for admission to Class XI provided the student is seeking admission in the year of passing Class X examination. Similarly, there will be no upper & lower age limit for admission to class XII provided there has been no break in the continuous study of the student after passing class XI.
