

The diameter of the circulating system can vary between 150 and 250 km. The eye is a region of calm with subsiding air. Around the eye is the eye wall, where there is a strong spiralling ascent of air to greater height reaching the tropopause. The wind reaches maximum velocity in this region, reaching as high as 250 km per hour. Torrential rain occurs here.
