PRIORITIES IN ADMISSION

The following priorities categories shall be followed in granting admissions:

CATEGORY 1. Children of employees of Project sector (ONGC)

CATEGORY 2. Children of Transferable and Non-transferable Central Government Employees and children of Ex- servicemen.

CATEGORY 3. Children of transferable and non-transferable employees of Autonomous Bodies/Public Sector Undertaking/Institute of Higher Learning of the Government of India.

CATEGORY 4. Children of transferable and non-transferable State Government employees.

CATEGORY 5. Children of transferable and non-transferable employees of Autonomous Bodies/Public Sector Undertakings/Institute of Higher Learning of the State Governments.

CATEGORY 6. Children from any other category i.e., all those not covered under any of the categories 1 to 5 listed above.

Note: Preference in Admission to wards will be based on the number of transfers of the parents in the last 7 years.
