All interested individuals / parties possessing valid PAN / TAN are invited to participate in the auction subject to the following conditions:



The same will be returned to the unsuccessful bidders within a week.
- A willingness letter along with self-attested copies of Aadhaar Card, PAN / TAN and transaction details of the security deposit must be submitted to this Vidyalaya by 28.02.2026.
- The base price of the items for each department will be determined by the undersigned.
- The auction shall be conducted strictly on "as is where is" basis.
- The highest bidder shall be required to deposit the entire bid amount immediately on conclusion of the auction process, failing which the bid will be cancelled and the security deposit will be forfeited.
- The articles will be handed over only after full payment has been made.

**Additional Terms and Conditions:**

- Bidders shall strictly abide by the rules declared at the time of auction.
- If the successful bidder fails to deposit the sale price, the items shall be offered to the next highest bidder.
- Employees of KVS and their relatives are not permitted to participate in the auction.

- The bid amount shall be paid on the same day itself on completion of the auction.
- The auctioned material must be lifted immediately after payment by the purchaser at their own cost of transportation and handling on the same day itself.
