The highest bidder must deposit the full bid amount (total value) for the items purchased at the auction on the same day the bidding process concludes. Following the auction, the successful bidder will be permitted to remove the items from the premises on that very day.

Bidders must strictly adhere to the prescribed rules and regulations during the auction proceedings.

1. It is mandatory for interested groups or individuals participating in the auction to submit valid proof of identity along with other relevant supporting documents.
2. Reporting time for marking attendance will be up to **11:00 AM**.
3. The minimum reserve price will be announced at the time of the auction.
4. If the highest bidder fails to deposit the stipulated amount at the time of the auction, the item will be sold to the second-highest bidder, and the highest bidder will have no grounds to raise an objection regarding this decision.
