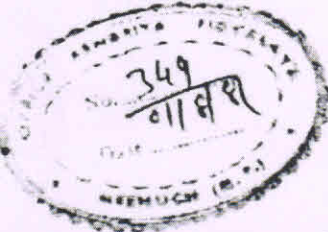

Sir,

The proposal of transfer of land to K.V.S. by State Govt. in respect of Civil Sector Schools on permanent grant basis has been discussed in Works Committee Meeting held on 2.5.89 and it has been decided that where the land is given on permanent grant basis and sanction order for transfer of land is issued by Governor of the State or the authority to whom the powers are delegated in the State Govt, execution of Lease Deed is not required.

In respect of all Civil Sector Vidyalayas where land has been allotted on permanent grant basis by the competent authority as mentioned above, the sanction order for transfer of land may be sent to Kendriya Vidyalaya Sangathan.
