ADMISSION NOTICE FOR CLASSES 10th & 12th SESSION 2026-27

Registration Open for few vacant seats in classes 10th & 12th subject to fulfil the following conditions.

FRESH ADMISSION FOR CLASS X AND XII

Fresh admissions to class X & XII, other than KV students, will be entertained subject to the availability of vacancies.

This will further be subject to the following conditions:

- a) The child has been in the same course of studies i.e. in a CBSE affiliated school.
- b) For Class X, the child must have obtained not less than 55% marks in aggregate in class IX.
- c) For admission to class XII, 55% marks in class XI examination is mandatory.
- d) The child should otherwise be eligible as per KVS Admission Guidelines.
- e) The combinations of subjects opted by the student are available in the concerned Kendriya Vidyalaya.
- f) Fresh Admission will be for priority category I to III only.

Interested candidates/parent can register themselves for desired class for the session 2026-2027. Registration form is available in the Vidyalaya Admission Department. Students/ parent can fill the registration form and submit the same along with required documents **from 02.04.2026 to 08.04.2026** during **09:00 AM to 11:00 AM on working days**.

The registration form will be accepted **till 04:00 PM on the last date i.e. 08-04-2026**. No form will be accepted after this. **The result of Admission will be declared on 13.04.2026**.

Priorities in admission will be given as per KVS(HQ), New Delhi **ADMISSION GUIDELINES 2026-2027**.

Documents to be submitted at the time of registration:

1. Filled registration form.
2. Mark sheet of previous passed class.
3. Proof of local residence.
4. Service Certificate issued by the competent Authority (For Government Employees)
5. Last 3 months Salary slip verified by the competent Authority (Only for Government Employees)

6. Copy of family history page from service record verified by the competent Authority (Only for Government Employees)
7. A service certificate showing the number of transfers during the preceding 7 years duly signed and stamped by the head of office bearing the name, designation and other relevant particulars in block letters. (Only for Government Employees)
8. A certificate of retirement for uniformed Defence employees.
9. Certificate (SC/ST/OBC-NCL/BPL/PH/EWS)
10. Proof of blood group
11. Adhar card of student and parents
12. Birth certificate of the child.
13. Permanent Education Number (PEN) certificate of the child (Mandatory for Class II onwards)
14. APAAR ID of the student.

Note: The Registration Forms will not be given/received after the due date and time for reasons whatsoever. Incomplete registration forms will be summarily rejected without assigning any reason thereof. Further, mere registration will not confer any right to admission.
