- e. Lightening conductors may be provided for high-rise buildings exceeding 5 floors.
- f. No High Tension Lines should run inside or in close proximity (< 6 meters) to any Educational institution buildings.

Let the above be tested and certified by any electrical Engineer without regard to any Jurisdiction under employment of Government of Andhra Pradesh once a year.

4. As the ensuring safety is a continuous learning process, we will advise from time to time, practical, modern, reliable but not too hard or that require major modifications to your building structure. And you shall undertake to observe these precautions to enhance fire safety.
