4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.

8. It will continue to pay an Annual Fee of Rs. 5000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee through link provided on Board website www.cbseaff.nic.in under the Government Schools Corner.
9. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates
10. As and when the school will shift to new location, it must be informed to the Board along with the following documents duly forwarded through the Kendriya Vidyalaya Sangathan of their region:-
 - i. Provide land documents of permanent site when the school will shift to new location.
 - ii. Fire Safety, Safe drinking water and Health & Sanitation Certificates duly issued by the Competent Authority of school for new location.
 - iii. Size & number of class rooms and size of labs.
 - iv. Building Safety Certificate of new location issued by the Issuing Authority.
11. Special conditions to be complied within 01 month:-
 - i) The school is required to appoint Special Educator as per rule 13(11) of Affiliation Bye Laws of the Board and as mentioned in Board circular dated 25/06/2015.
 - ii) The School is required to follow the safety guidelines as issued by the Board vide Circular No.-19/2017, dated 12/09/2017 captioned "Safety of Children in Schools".
