Authority Agencies for Safe Disposal & Recycling of E-Waste, Registration Certificate of the firm and other necessary proofs/IDs with specific Terms and Conditions (if any) along with Rs. 1000/- for auction money (EMD) in advance. The Auction of all items will be done on 01.05.2025 at 11:00AM

## निबंधन / Terms and Conditions :

- 1. The participants shall abide by the rules to be declared at the time of auction and have to deposit Rupees 1000/- as EMD before taking part in the auction process.
- 2. Reserved Price will be revealed only at the time of auction.
- 3. The bidder has to mandatory submit self-attested copies of valid Certificates issued by Govt. agencies for safe disposal and recycling of E-waste, registration Certificate of the Firm along with other necessary proofs/Ids like Voter Card, Aadhar Card, PAN etc. have to be deposited.
- 4. No item/ items, once sold to the successful bidder shall be taken back.
- 5. If the successful bidder fail to pay the sale price his/her EMD will be forfeited and the items shall be sold to the next higher bidder until process is completed.
- 6. The successful bidder has to make full balance payment (i.e; by adjusting EMD amount also) immediately to be deposited in Vidyalaya Vikas Nidhi Bank account and vacate the Premises immediately by taking out the auctioned electronic waste articles for proper disposal on his own resources and cost.
