Employees among others.
- 2. Sealed competitive quotations from firms who are having valid license & registration are invited by the Principal PM Shri Kendriya Vidyalaya Adoor Pathanamthitta for supply and installation of CCTV Surveillance system as per the schedule/ details attached.

3. Terms and conditions

- a) The contract shall be for the work of the mentioned items for PM Shri Kendriya Vidyalaya, Adoor Pathanamthitta. The bidder shall quote the rates for items of work in the attached format (Annexure I). Corrections, if any, shall be made by crossing out, initialling with date and rewriting.
- b) All taxes, duties and other levies payable by the bidder, shall be included in the total price. They shall be quoted separately. No additional payment will be done for anything that is not quoted.
- c) The rates quoted by the bidder shall be fixed for the duration of the contract i.e.for 180 days from the date of award of the contract.
- d) Each bidder shall submit only one quotation.
- e) Quotations are not acceptable if submitted through e-mail/Fax etc
- f) The bid should be submitted along with EMD for Rs. 5000/- (Rupees Five Thousand Only) through NEFT/RTGS or bank draft in favour of "Kendriya Vidyalaya Adoor Shift I Vvn A/c" payable at Adoor. The EMD paid will be refunded in the case of unsuccessful bidders within 90 days from the date of opening of Quotations.
- g) e-PERFORMANCE BANK GUARANTEE (ePBG):
 The successful vendor shall have to furnish a Bank Guarantee (ePBG) for 3% of the Total
 QUOTED value within 05days from the date of order of contract. If the supplier fails to
 submit the ePBG within 05days from the date of PO, the buyer reserves the right to cancel
 the order and forfeit the EMD if given by the supplier. Additionally, in such case, action
 will be initiated in line with GFR conditions. Validity of ePBG shall be from order date
 till the completion of Warranty Period +2 months.
- h) The firm should enclose supporting documents regarding registration of GST/IT—PAN/TAN/Registration Certificates from department concerned without fail.
- i) Quantity may vary as per the actual requirement.
- j) Party will be responsible for making good the damages on installation if any.

4. Additional Terms and Conditions

- a) The awardee of the contract shall begin the work only after obtaining the APPROVAL OF THE Work Monitoring Committee with regard to the quality of the Material to be used for the work.
- b) The tools for installing CCTVs and other accessories, ladders, etc. to be brought by the awardee and the rates quoted should include all these. At no cost, such materials shall be provided by the Vidyalaya.
- c) No material/ services for supply and installing CCTVs along with its accessories shall be provided by the Vidyalaya.
- d) The awardee of the contract shall be liable to compensate the damages caused to the Building or the materials in the building, if any, during the work.
- e) The awardee of the contract shall be liable to pay compensation/penalty if the said work is not completed within the stipulated time.
- f) Tax Deducted at Source(TDS)/GSTTDS will be deducted as per applicable Rates.
- g) All products must have Quality Assurance certificate on the directions of respective Government/Testing labs.

- h) Companies registered under MII or MSME will be provided with necessary exemptions as mandated.
- i) The bidder should have positive financial net worth.
- j) Bidder should submit documents of previous experience of similar installation(s).

4. Validity of quotations

The quotation shall remain valid for a period not less than 180 days after the deadline specified for submission of quotations.

5. Evaluation of quotations

The Purchases will evaluate and compare the quotations determined to be substantially responsive, i.e., which are:

- a. Properly signed
- b. Confirm to the terms and conditions and specifications.

The evaluation would be done for all the items/services put together. The items/services for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly, the bidder who has quoted for partial quantity of any one or more item(s) would be treated as non-responsive. The purchaser shall keep in mind that the rates quoted shall be competitive and do not in any manner whatsoever compromise with the quality of item and services to be provided by him as per the terms and conditions. PM Shri KV Adoor, Pathanamthitta will award the contract to the responsive bidder whose total cost for all the items put together is the lowest. However, this does not restrict the purchaser from imposing any further conditions before awarding the contract.

6. Award of contract:

- a) The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price as mentioned above.
- b) The bidder whose bid is accepted will be notified of the award of the contract by the office prior to expiration of the quotation validity period.
- c) The Notification of Award shall be clearly specifying any change in the unit price or any other terms and conditions accepted.
- d) Normal commercial warranty/guarantee shall be applicable to the supplied Goods/Services.
- e) Payment shall be made within 20 days after the work is completed.
- f) Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.

7. Last date and time of receipt of quotations:

The quotations and/or documents should be in sealed cover with super scribed on the envelop as "Quotations for supply and installation of CCTV surveillance system" and should reach in this Vidyalaya on or before 15 March 2025 (1400 Hrs). The quotation shall be opened on the same day (15.03.2025) at 1430 Hrs. The representatives who choose to be present at the time of opening of quotations are invited to the Vidyalaya to attend the proceedings.
