Subject: Conduct of Learners' Achievement Test (LAT) I for Classes 3, 5, and 8 for the Session 2025-26-reg.

Madam/Sir,

KVS conducted two Learners' Achievement Tests (LAT) during the academic session 2024-25 for classes 3, 5, and 8. Recognizing its positive impact, the competent authority has approved the continuation of LAT in the session 2025-26 as well.

The LAT -1, 2025-26 for grades 3, 5, and 8 will be conducted as per the following schedule:

Date: 03 April 2025

Time: 9:00 am to 11:00 am for classes 3 and 5; and from 9:00 am to 11:30 am for class 8 for both shifts

The following are the key-aspects of the test items included in the LAT papers:

The design of test items will be focusing on the following key aspects:

- 1. Assessment Items: The test items will be derived from NCERT books of previous grades and aligned with the specified learning outcomes. They will consist of multiple-choice questions with a single correct response, carefully structured to assess students' prior learning and readiness for the next grade.
- 2. Alignment with Previous Grades: The test will emphasize foundational concepts from previous grades, ensuring alignment with the learning outcomes for those levels.

3. **Cognitive Skills:** The assessment will include questions that go beyond rote memorization, encouraging a deeper understanding and fostering critical thinking skills.

Furthermore, maintaining the integrity of the test is of utmost importance. To ensure its smooth conduct, Regional Offices are expected to adhere to the following guidelines:

- Password-protected question papers will be sent to the Regional Offices on 27/28 March, 2025, and the scoring key will be e-mailed on 03 April, 2025. Evaluation should strictly follow the provided keys, and results must be compiled at the school level.
- **Prompt Delivery of Question Papers**: Regional Offices must ensure that schools receive the question papers **one day prior** to the test date. Clear instructions should be provided to schools regarding necessary arrangements for printing, such as RISO, photocopiers, or printers, to accommodate the student strength in Classes 3, 5, and 8.
- Evaluation & Result-preparation: Similar to LAT-1 of the previous year, schools will be required to enter students' responses in the Google Worksheets provided by KVS HQ.
- Overall Report Preparation: Regional Offices must ensure that all schools under their jurisdiction complete the evaluation and data entry in the Google Worksheets by 8th April 2025 for further necessary action.

It is anticipated that the LAT-1 exam for 2025-26 will offer an accurate reflection of our students' progress, enabling us to take appropriate measures to support their academic development.
